The State of Wisconsin, Pharmacy Examining Board, having considered the above-captioned matter and having reviewed the Stipulation and Proposed Decision, makes the following:


ORDER

NOW, THEREFORE, it is hereby ordered that the Proposed Decision annexed hereto, shall be and hereby is made and ordered the Final Decision of the State of Wisconsin, Pharmacy Examining Board. Let a copy of this Order be served on the Respondent by certified mail.

A party aggrieved by this decision may petition the Board for rehearing within twenty (20) days after service of this Decision pursuant to section 227.12, Wisconsin Statutes. The party to be named as Respondent in the petition is Steven J. Robertson.

A party aggrieved by this Decision may also petition for a judicial review by filing the petition in the office of the Clerk of the Circuit Court for the county where the judicial review proceedings will be held and serving the Board and other parties with a copy of the petition for judicial review within thirty (30) days after service of this Decision pursuant to section 227.16, Wisconsin Statutes. The party to be named as Respondent in the petition is the State of Wisconsin, Pharmacy Examining Board.

FINDINGS OF FACT

1. That Steven J. Robertson, hereinafter called the respondent, was at all times material to this complaint dully licensed under the provisions of Chapter 450, Wisconsin Statutes, to practice as a registered pharmacist in the State of Wisconsin.

2. That the respondent's pharmacist license is #9273, issued November 10, 1977.

3. That the respondent's last address reported to the Pharmacy Examining Board is 1752 South 63rd Street, West Allis, Wisconsin 53214.

4. That on June 25, 1981, the respondent and his wife went to Summerfest, in Milwaukee, Wisconsin.

5. That on said date at Summerfest, the respondent was arrested for possession of marijuana, and was found to have in his possession a bottle containing various pills.

6. That said bottle contained the following:

- a. One Biphetamine capsule, a Schedule II drug;
- b. One Dexedrine capsule, a Schedule II drug;
- c. Four capsules containing Diphenhydramine HCL, a prescription drug;
- d. Two tablets containing Ephedrine, Theophylline, and Phenobarbital, an over-the-counter preparation;
- e. One tablet containing Pseudoephedrine, a prescription drug;
- f. Two Benadryl Kapseals, a prescription drug;
- g. Two Bellergal-S tablets, a prescription drug;
- h. Two aspirin tablets;

- i. One Vistaril capsule, a prescription drug;
- j. One Drixoral Sustained Action tablet, a prescription drug;
- k. One Donnatal tablet, a prescription drug;
- l. One Actifed tablet, a prescription drug; and
- m. One Sudafed tablet, an over-the-counter preparation.

7. That upon payment of terms of \$100.00, the charge of possession of marijuana was dismissed by the Milwaukee County Circuit Court on August 26, 1981.

8. That no other charges were brought against the respondent or are pending against the respondent based on the June 25, 1981 incident.

9. That the respondent has never been convicted of any criminal offense.

10. That the various pills possessed by the respondent on June 25, 1981, had been in his possession since 1976 or 1977, when he obtained these items while a pharmacy intern.

11. That the respondent is not drug dependent.

#### CONCLUSIONS OF LAW

1. That by possessing controlled substances and prescription drugs as described in the Findings of Fact, the respondent has violated Chapter 450 and 161, Wisconsin Statutes.

2. That the Pharmacy Examining Board has jurisdiction to take disciplinary action against the respondent for violations of Chapter 450 and Chapter 161, Wisconsin Statutes, pursuant to section 450.02(7)(a), Wisconsin Statutes.

#### ORDER

NOW THEREFORE, IT IS ORDERED that the respondent, Steven J. Robertson, is hereby REPRIMANDED.
