A party aggrieved by this decision may petition the Board for rehearing within twenty (20) days after service of this decision pursuant to Wis. Stats. sec. 227.12. The petition in this instance would be captioned with Suzanne Schedrsky as the respondent.

A party aggrieved by this decision may also petition for judicial review by filing the petition in the office of the clerk of the circuit court for the county where the judicial review proceedings will be held and serving the Board or other parties with a copy of the petition for judicial review within thirty (30) days after service of this decision pursuant to Wis. Stats. sec. 227.16. The party to be named as respondent in said petition would be the Board of Nursing.

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Suzanne Schedrsky, T.P.N. (hereinafter respondent) is and was at all times relevant to this complaint duly licensed as a trained practical nurse in the State of Wisconsin (license #11928); this license was issued on December 13, 1971.

2. In 1980, respondent worked as a trained practical nurse on Units 9 and 10 at Dane County Hospital and Home, Verona, Wisconsin. Units 9 and 10 house developmentally disabled patients who need assistance with their daily activities.

3. Part of respondent's duties at Dane County Hospital and Home was to do shopping for patients on Units 9 and 10. Respondent withdrew money from the individual patient's accounts for this purpose.

4. Between July and October, 1980, respondent diverted approximately \$1,500.00 from patient accounts for her own use.

CONCLUSIONS OF LAW

Respondent, by the conduct described above, is subject to disciplinary action against her license under Wis. Stats. sec. 441.07(1)(c) and (d).

Therefore, it is hereby ORDERED:

The license of Suzanne Schedrsky, T.P.N. (#11928) is suspended for a period of ninety (90) days; the serving of sixty (60) days of the suspension is stayed. The remaining thirty (30) day suspension shall commence fifteen (15) days from the date of this order.

STIPULATION

It is hereby stipulated between Suzanne Schwedrsky, T.P.N., personally and by her attorney D.C. Pressentin, and Steven M. Gloe, attorney for the Department of Regulation and Licensing, Division of Enforcement, as follows that:

1. This Stipulation shall be submitted to the Board of Nursing to form the basis for the Final Decision and Order in this matter.
2. The parties reserve the right to present their recommendations for discipline orally before the Board of Nursing, based upon the facts agreed upon pursuant to this Stipulation. The parties anticipate appearing before the Board on September 24, 1982 and request a time be set for such appearance. Other than this appearance, the parties consent to the entry of a Final Decision and Order by the Board without further notice, pleading, appearance or consent of the parties.
3. In settlement of this matter, Respondent amends her answer to admit the allegations of the Amended Complaint filed in this action, therefore allowing the Board to make findings consistent with these allegations.
4. The parties further agree that the Respondent has participated in the Dane County First Offenders Program in relation to the diversion of funds described in the complaint. As part of this program, Respondent has paid back approximately \$1,500 to Dane County, as well as provided 100 hours of volunteer work at Mendota Mental Health Institute.
5. The Division of Enforcement recommends that the license of Suzanne Schwedrsky, T.P.N. be suspended for a period of ninety (90) days, to commence on a date fifteen days following the date of the Board order in this action. Based on its review of the Board's decision in Disciplinary Proceedings

against Christine Kreuger, R.N., The Division recommends 60 of these days be applied retroactively. The Respondent shall present arguments for the imposition of a lesser discipline.

On September 24, 1982, the Wisconsin Board of Nursing took action to accept the Final Decision and Order in your behalf. This action suspends your license for 90 days, 60 days of which are stayed. The remaining 30 days suspension begins on October 8, 1982 and will conclude on November 6, 1982.

The Board agreed to stay a portion of the suspension due to the fact that you have made restitution and have participated in a work program in which you have volunteered one hundred hours of work at Mendota Mental Health Institute.
