IN THE MATTER OF THE LICENSE TO PRACTICE MEDICINE AND SURGERY OF

ORDER

RUTH C. FOSTER, M.D., LICENSEE.

Based upon the attached Stipulation of the parties, the Wisconsin Medical Examining Board hereby makes and enters the following:

ORDER

NOW THEREFORE, IT IS ORDERED that the Wisconsin Medical Examining Board hereby accepts and approves the attached Stipulation.

IT IS FURTHER ORDERED, that Department of Regulation & Licensing, Division of Enforcement, investigative file 84 MED 88 is closed.

IT IS FURTHER ORDERED, that Ruth C. Foster, M.D., Licensee, shall immediately surrender to the United States Drug Enforcement Administration or its representatives her DEA registration, and all controlled substances and all unused DEA 222 Order Forms, in her possession or control.

IT IS FURTHER ORDERED, that the Wisconsin Medical Examining Board hereby accepts the voluntary surrender of Ruth C. Foster's unlimited license to practice medicine and surgery in the State of Wisconsin.

IT IS FURTHER ORDERED, that the Licensee, Ruth C. Foster, M.D., shall be, and hereby is granted a limited license to practice medicine and surgery in the State of Wisconsin, which is limited by the following conditions, requirements and restrictions which shall remain in effect until removed or amended by order of the Wisconsin Medical Examining Board:

- 1. Ruth C. Foster, M.D., shall not dispense, prescribe, administer, or distribute any controlled substances, as defined by Chapter 161, Wis. Stats.
- 2. That proof of violation of any of these conditions, requirements, and restrictions, after hearing, shall result in the revocation of this license to practice medicine and surgery.
- 3. Ruth C. Foster, M.D., shall refrain from engaging in unprofessional conduct, shall appear before the Board or its officers or agents at such times and places as may be designated by the Board from time to time, shall fully disclose to the Board or its officers

or agents the nature of Ruth C. Foster's practice and conduct and shall cooperate with the Board during the entire period of this limited license. (Wis. Stats. sec. 448.02)

4. That if after May 1, 1989 Ruth C. Foster, M.D. appears before the Wisconsin Medical Examining Board and shows to the satisfaction of the Board evidence of knowledge necessary for the dispensing, prescribing, and administering, of controlled substances, and if, Ruth C. Foster, M.D. has not violated this limited license, then following June 29, 1989, she shall be granted a full license to practice medicine and surgery in the State of Wisconsin, if she is otherwise qualified under statutory and Wisconsin Medical Examining Board rule requirements.
