A party aggrieved by this decision may petition the board for rehearing within twenty (20) days after service of this decision pursuant to Wis. Stats. sec. 227.12. The party to be named as respondent in the petition is Mildred Stone, M.D.

A party aggrieved by this decision who is a resident of this state may also petition for judicial review by filing the petition in the office of the clerk of the circuit court for the county where the party aggrieved resides within thirty (30) days after service of this decision. A party aggrieved by this decision who is not a resident of this state must file the petition for judicial review in the office of the clerk of circuit court for Dane County. A party aggrieved must also serve the board and other parties with a copy of the petition for judicial review within thirty (30) days after service of this decision pursuant to Wis. Stats sec. 227.16. The party to be named as respondent in the petition is the Medical Examining Board.

The Medical Examining Board has received a Stipulation in the above-captioned matter executed by Mildred Stone, M.D.; by Wm. Pharis Horton, attorney for Dr. Stone; and by Pamela M. Stach, attorney with the Department of Regulation and Licensing Division of Enforcement. A copy of the Stipulation is attached hereto and made a part hereof. The board considered the Stipulation at its meeting of June 29, 1984 and orders as follows:

- The Stipulation of the parties to this matter is hereby accepted and adopted by the State of Wisconsin Medical Examining Board.
- By its acceptance of the Stipulation filed in this matter, the board hereby accepts the voluntary surrender by Mildred M. Stone, M.D. of her registration to practice medicine and surgery in the State of Wisconsin effective July 1, 1984.
- Mildred Stone, M.D., shall not renew her license to practice medicine and surgery in the State of Wisconsin on the renewal date of December 31, 1985, or at any time subsequent to that date, without first complying with the following terms and conditions:
 - In the event Dr. Stone wishes to resume the active practice of medicine and surgery she will inform the Medical Examining Board of her intention at least ninety (90) days prior to any anticipated resumption.
 - b. Prior to resuming the active practice of medicine and surgery, Dr. Stone agrees to appear before the Medical Examining Board and demonstrate to the satisfaction of the Board her fitness to practice under her license.
 - Dr. Stone agrees to submit to the Medical Examining Board satisfactory evidence that she has, after the date of this Stipulation, taken and successfully passed the FLEX examination before being permitted to re-register.
- All pending investigations by the Medical Examining Board relating to the practice of Mildred Stone, M.D. are hereby terminated.
