ORDER

RICHARD HAUSER, M.D., LICENSEE.

Based upon the attached Stipulation of the parties, the Wisconsin Medical Examining Board hereby makes and enters the following:

## ORDER

IT IS HEREBY ORDERED, that the following terms, conditions and limitations shall be imposed upon the license to practice medicine and surgery in the state of Wisconsin of Richard L. Hauser, M.D.:

- 1. The terms, conditions, and limitation set forth herein shall remain in full force and effect for a period of two (2) years from the date of this order.
- 2. Roland E. Herrington, M.D., Director of the DePaul Rehabilitation Hospital Impaired Professional Program and a physician agreed upon by Dr. Herrington and Dr. Hauser shall be Dr. Hauser's co-supervising physicians throughout the full term of the limitations. If they are unable to agree upon a co-supervisor, or if at any time any co-supervisor is unable to serve in such role, then the Medical Examining Board shall have sole discretion to appoint a co-supervisor or replacement.
- 3. Dr. Hauser shall participate in all components of the DePaul Rehabilitation Hospital Impaired Professional Program at the DePaul Rehabilitation Hospital or at such other locations and facilities as his supervising physicians shall determine to be appropriate for his rehabilitation.
- 4. That Dr. Hauser shall abstain from any and all personal use of controlled substances as defined in Wis. Stats. sec. 161.01(4) except when necessitated by a legitimate medical condition and then only with the prior approval of the supervising physicians.
- 5. Dr. Hauser shall abstain from any and all personal use of alcohol.
- 6. Dr. Hauser shall report all medications and drugs, over-the-counter or prescription, taken by him to his supervising physicians within 24 hours of ingestion or administration, and shall identify the person(s) who prescribed, dispensed, administered or ordered such medication or drugs for him.
- 7. Dr. Hauser shall supply on at least a twice weekly basis random monitored urine or blood specimens within 24 hours of a request for said specimen made by a supervising physician or his designee. A supervising

physician or his designee shall determine whether the specimen shall be a urine specimen or a blood specimen or both. Collection of these specimens shall be observed and verified by persons designated by a supervising physician.

- 8. If any urine or blood specimen is positive or suspected positive for any controlled substances or alcohol, Dr. Hauser shall promptly submit to additional tests and examinations as the supervising physicians shall determine to be appropriate to clarify or confirm the positive or suspected positive urine or blood test results.
- 9. Dr. Hauser will attend on a weekly basis at least two Alcoholics Anonymous group meetings. One of these meetings will be with a professional Alcoholics Anonymous group and the other meeting will be with a community Alcoholics Anonymous group. Dr. Hauser shall be responsible to ensure that his attendance at these meetings is documented in written form by the secretary of each Alcoholics Anonymous group and that this written documentation is submitted promptly to Dr. Hauser's supervising physicians.
- 10. The supervising physicians shall submit formal written reports to the Medical Examining Board every 90 days commencing 90 days after the date of this order. The reports shall assess Dr. Hauser's progress in his rehabilitation program and set forth the results of the random urine and blood screens. Dr. Hauser shall be responsible for the timely filing of these reports. The supervising physicians and Dr. Hauser shall immediately report to the Medical Examining Board any suspected violations of this Order.
- 11. Dr. Hauser shall provide and keep on file with his supervising physicians and all treatment facilities and personnel current releases which comply with state and federal laws authorizing release of all of his medical and treatment records and reports to the Medical Examining Board, and permitting his supervising physicians and his treating physicians and therapists to discuss and disclose the progress of his treatment and his rehabilitation with the Medical Examining Board. Copies of said releases shall be filed simultaneously with the Medical Examining Board.
- 12. Dr. Hauser shall appear before the Medical Examining Board at least annually to review the progress of his rehabilitation. Dr. Hauser may petition the Medical Examining Board annually for modification of the terms, conditions and limitations set out in this Order and the Medical Examining Board shall consider Dr. Hauser's petition at the time it meets with Dr. Hauser to review the progress of his rehabilitation. Denial of the petition in whole or in part shall not be considered a denial of license within the meaning of Wis. Stats. sec. 227.01(2)(a) and Dr. Hauser shall not have a right to any further hearing on any denial, in whole or in part, of his petition.

IT IS FURTHER ORDERED that violation of any term, condition, or limitation imposed by this Order may constitute grounds for revocation of

Dr. Hauser's license to practice medicine and surgery in the State of Wisconsin.

IT IS FURTHER ORDERED that Department of Regulation and Licensing, Division of Enforcement, investigative file 83 MED 313 is closed.
