IN THE MATTER OF THE LICENSE TO PRACTICE MEDICINE AND SURGERY OF :

ORDER ADOPTING STIPULATION

SCOTT S. HARRIS, M.D.

:

The Wisconsin Medical Examining Board having met on September 13, 1984, and having received and considered a STIPULATION, a copy of which is attached hereto and incorporated herein;

And the Wisconsin Medical Examining Board having determined that it has jurisdiction to act in this matter pursuant to Wis. Stats. secs. 448.02(3) and 448.02(5);

NOW THEREFORE, IT IS ORDERED THAT:

- The terms of the attached STIPULATION are approved and adopted by the Wisconsin Medical Examining Board.
- The Wisconsin Medical Examining Board accepts the voluntary surrender of Dr. Scott S. Harris' current registration to practice medicine and surgery in the State of Wisconsin.
- If at any time Scott S. Harris makes application for re-registration in the State of Wisconsin, he will, as a prerequisite for re-registration, comply with all requirements for re-registration as provided by law and provide evidence satisfactory to the Wisconsin Medical Examining Board that he has been rehabilitated. If the Wisconsin Medical Examining Board, in the exercise of its discretion, is not satisfied that Scott S. Harris has been sufficiently rehabilitated to warrant re-registration permitting the full and unrestricted practice of medicine and surgery in the State of Wisconsin, the Wisconsin Medical Examining Board shall grant Scott S. Harris a limited license under terms and conditions acceptable to the Wisconsin Medical Examining Board providing for continued participation in a drug or alcohol rehabilitation program with adequate monitoring for drug and alcohol abuse. At the time of application for re-registration, Scott S. Harris shall provide the Wisconsin Medical Examining Board with current medical releases which comply with state and federal law authorizing release of all of his medical and treatment records from all treatment facilities and therapists who participated in his drug rehabilitation program or who evaluated him for drug or alcohol dependence or abuse.
- The granting of an application for re-registration and a limited license pursuant to the terms of the Stipulation shall not be considered a denial of a license within the meaning of Wis. Stats. sec. 227.01(2)(a). Scott S. Harris has waived all rights to a hearing on any denial of an application for re-registration made pursuant to the terms of the Stipulation which, if granted, would permit him to engage in the practice of medicine and surgery in the State of Wisconsin under a full and unrestricted license.

- 5. Scott S. Harris shall not practice or attempt to practice medicine and surgery in the State of Wisconsin when not currently registered.
- 6. Pending investigation #84 MED 69 shall be terminated and no formal complaint shall be issued.
