IN THE MATTER OF THE LICENSE TO PRACTICE MEDICINE AND SURGERY OF

ORDER

JOHN R. NEILL, M.D.,

LICENSEE.

Based upon the attached Stipulation of the parties, the Wisconsin Medical Examining Board hereby orders as follows:

- 1. That Wisconsin Department of Regulation and Licensing, Division of Enforcement, investigative file 84 MED 176, regarding John R. Neill, M.D., is hereby closed.
- 2. That John R. Neill's voluntary surrender of his registration to practice medicine and surgery in the State of Wisconsin is hereby accepted.
- 3. That in the event that John R. Neill, M.D. shall ever reapply to be registered to practice medicine and surgery in the State of Wisconsin, that the Wisconsin Medical Examining Board shall impose appropriate conditions upon his license and that registration, including that John R. Neill, M.D. provide proof that he has obtained a sufficient number of Category I continuing medical education credits from January 1, 1982 to the time he applies for reregistration to average at least 15 such credits per year.
