On March 6, 1985 the parties to the above-captioned matter submitted a Stipulation to the Medical Board executed by Sally C. Mendenhall, M.D., respondent herein; by David S. Uphoff, attorney for respondent; and by Pamela M. Stach, attorney for the Department of Regulation and Licensing. A copy of the Stipulation is attached hereto and made a part hereof.

Based upon the Stipulation and upon the pleadings in this matter, the Medical Examining Board makes the following order:

ORDER

NOW, THEREFORE, IT IS ORDERED that the attached Stipulation in this matter, including Findings of Fact and Conclusions of Law contained therein, be, and hereby is, accepted and adopted by the State of Wisconsin Medical Examining Board.

IT IS FURTHER ORDERED that Sally C. Mendenhall, M.D., be, and hereby is, reprimanded.

IT IS FURTHER ORDERED that the license of Sally C. Mendenhall, M.D., to practice as a physician and surgeon in the State of Wisconsin be, and hereby is, limited for a period of six months commencing thirty days following the date hereof. The terms and conditions of the limitation are as follows:

- (1) Sally C. Mendenhall, M.D., shall refrain from the dispensing, prescribing or supplying of any Schedule II narcotic controlled substance unless her patient's condition specifically requires such medication.
- (2) In the event Sally C. Mendenhall, M.D., believes her patient's condition requires a Schedule II narcotic controlled substance, she shall review the patient's condition with one of the following three supervising physicians: J.D. Kabler, M.D., Joseph M. Benforado, M.D., or Irwin F. Koenig, M.D. Sally C. Mendenhall, M.D., may prescribe a Schedule II narcotic controlled substance for her patient only when the supervising physician concurs with this medical judgment and makes an entry in the patient's chart so indicating.
- (3) At the conclusion of the six-month limitation of Sally C. Mendenhall, M.D.'s license, she agrees to allow the supervising

physicians to submit a report to the Medical Examining Board describing her compliance with the supervision procedures.

- (4) Sally C. Mendenhall, M.D., also agrees to permit the supervising physicians to report to the Medical Examining Board any instance of non-compliance with the supervision requirements.
- (5) Sally C. Mendenhall, M.D., shall submit a written statement from the supervising physicians accepting the conditions of supervision outlined above.
- (6) Sally C. Mendenhall, M.D., shall participate in and complete two continuing education programs in the subject area of narcotic substances within the period of limited license. She shall submit evidence of attendance of these courses to the Medical Examining Board immediately upon completion.
- (7) It shall be the responsibility of Sally C. Mendenhall, M.D., to ensure that the original letter of acceptance from supervising physicians, the completion evaluation, and the evidence of attendance at the continuing education program are submitted to the Board on a timely basis.

IT IS FURTHER ORDERED that Counts I through III of the complaint filed herein be, and hereby are, dismissed.
