On September 16, 1985 the Board of Nursing issued an Amended Order in the above-captioned matter changing the terms of the limited license granted to Ms. Grady by the Board's Order dated May 20, 1985. Through a confusion of records, the Amendment made to the May 20, 1985 Order was incorrect in ordering reduction in frequency of required drug screens. What Ms. Grady had requested, and what the Board considered on July 18, 1985, was a reduction in the frequency of required sessions with her therapist. Accordingly, the Board orders as follows:

ORDER

IT IS ORDERED that the Amended Order in the Matter of Disciplinary Proceedings Against Barbara Joan Grady, R.N., dated September 16, 1985 is null, void and of no effect.

IT IS FURTHER ORDERED that subparagraph (b)i of the Final Decision and Order of the Board dated May 20, 1985, is hereby amended to read as follows:

1. Ms. Grady must remain in a program acceptable to the Board for the treatment of chemical dependency. As a part of her treatment, Ms. Grady must attend therapy on a schedule as recommended by her therapist; attendance, however, shall be required at least one time per month. In addition, Ms. Grady must attend Alcoholics Anonymous or Narcotics Anonymous at least one time per week.
