Based upon the attached Stipulation of the parties, the Wisconsin Medical Examining Board hereby orders as follows:

NOW, THEREFORE, IT IS ORDERED that the attached Stipulation of the parties is accepted by the Wisconsin Medical Examining Board.

IT IS FURTHER ORDERED that Wisconsin Department of Regulation and Licensing, Division of Enforcement, investigative file 84 MED 258, regarding Benjamin S. Greenwood, M.D., is hereby closed.

IT IS FURTHER ORDERED that Benjamin S. Greenwood, M.D., shall be and is Reprimanded for failing to retain verification of having taken 30 Category I continuing medical education credits during 1982-83, prior to registering for the 1984-85 biennium.

IT IS FURTHER ORDERED that if Licensee registers to practice medicine and surgery in the State of Wisconsin for the 1986-87 biennium, that he shall submit to the Wisconsin Medical Examining Board proof that he has obtained 48 Category I continuing medical education credits during 1984 and 1985. That the 48 continuing medical education credits represents the 18 credits Licensee was short for 1982-83 and the 30 continuing medical education credits which would be required during 1984 and 1985.
