ORDER ADOPTING STIPULATION

WILLIAM N. YOUNG, M.D. :

The Wisconsin Medical Examining Board having met on May 24, 1984, and having received and considered a STIPULATION, a copy of which is attached hereto and incorporated herein;

And the Wisconsin Medical Examining Board having determined that it has jurisdiction to act in this matter pursuant to Wis. Stats. sec. 448.02(5);

NOW THEREFORE, IT IS ORDERED THAT:

- 1. The terms of the attached STIPULATION are approved and adopted by the Wisconsin Medical Examining Board.
- 2. The Wisconsin Medical Examining Board accepts the voluntary surrender of Dr. William N. Young's current registration to practice medicine and surgery in the State of Wisconsin.
- 3. Pending investigation #83 MED 204 shall be terminated and no formal complaint shall be issued.
- 4. If at any time Dr. Young makes application for re-registration to practice medicine and surgery in the State of Wisconsin, he shall at the time he makes application take and pass all examinations required for original licensure, and shall comply with all terms and conditions for restoration of his registration as the Wisconsin Medical Examining Board may deem appropriate.
