The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

#### FINDINGS OF FACT

- 1. Gerri D. Dunne (D.O.B. 01/26/30) is duly licensed as a registered nurse in the state of Wisconsin (license #26138). This license was first granted on January 10, 1952.
- 2. Ms. Dunne's most recent address on file with the Wisconsin Board of Nursing is 3121 School Street, Two Rivers, WI 54241.
- 3. The Division has received allegations concerning Ms. Dunne's management of care in her role as Director of Nursing at Park Lawn Nursing Home in Manitowoo, Wisconsin. Ms. Dunne contests those allegations, but for reasons of health and in resolution of this matter consents to entry of the following Conclusions of Law and Order.

#### CONCLUSIONS OF LAW

The Board of Nursing is authorized to issue the following order concerning the licensure of Gerri D. Dunne as a registered nurse in the state of

Wisconsin, pursuant to Wis. Stats. §441.07(1) and Wis. Adm. Code §N7.04.

#### ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that the license of Gerri D. Dunne, RN to practice as a registered nurse in the state of Wisconsin (#26138) shall be LIMITED as follows: Until such time as approved by the Board, Ms. Dunne shall refrain from nursing employment which involves her acting in a supervisory capacity.

In conjunction with a petition by Respondent for removal of this limitation, the Board shall require Ms. Dunne to appear before the Board to address any concerns and answer questions the Board may have relative to this matter. The Board in its discretion shall then determine (if any) the terms and conditions necessary for public health and safety under which the respondent may be employed in a supervisory capacity. Denial in whole or in part of a petition under this paragraph shall not constitute denial of a license and shall not give rise to a contested case within the meaning of Wis. Stats. §§227.01(3) and 227.42.

Ms. Dunne may submit a petition to alter the limitation on her license at any time.

Violation of any of the terms of this Order shall be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Mr. Dunne's license; the Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order.

This Order shall become effective upon the date of its signing.
