STIPULATION

It is hereby stipulated between Anne M. Love, R.N. personally on her own behalf and Steven M. Gloe, attorney for the Department of Regulation & Licensing, Division of Enforcement, as follows that:

1. This stipulation is entered into as a result of a pending investigation of Ms. Love's licensure by the Division of Enforcement (case file number 84 Nurse 77). Ms. Love consents to the resolution of this investigation by stipulation and without the issuance of a formal complaint.
2. Ms. Love understands that by the signing of this stipulation she voluntarily and knowingly waives her right to a hearing on the allegations against her.
3. Ms. Love agrees to the adoption of the attached Final Decision and Order by the Board of Nursing.
4. If the terms of this stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this stipulation, and the matter shall be returned to the Division of Enforcement for further proceedings.
5. If the Board accepts the terms of this stipulation, the parties to this stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties.
6. Ms. Love hereby agrees to surrender her license to practice as a registered nurse in the State of Wisconsin. Ms. Love has submitted her licensure card to the Division of Enforcement. If the Board does not accept this stipulation, the license of Ms. Love shall be returned to her with the notice of the Board's decision not to accept the stipulation.
7. The Division of Enforcement joins Ms. Love in recommending the Board of Nursing adopt this stipulation and issue the attached Final Decision and Order.
