The Executive Committee having received evidence concerning the alleged misconduct of David Schoonhoven, CADC III now makes the following:

Findings of Fact

- On July 24, 1990, David Schoonhoven was charged in Outagamie County Court with four counts of sexually exploiting a female client.
- 2. The four counts are Class D felonies.
- 3. The case was continued until August 9, 1990.
- Sexually exploiting a client is grounds for discipline under the WADCCB Code of Conduct.

CONCLUSIONS

- The WADCCB Executive Committee makes no determination as to the innocence or guilt of Mr. Schoonhoven at this time.
- The Executive Committee, however, believes that it is inappropriate for Mr. Schoonhoven to be credentialed as a certified alcohol drug counselor as long as the case is pending.
- The Executive Committee will wait for the outcome of the Outagamie County Court case before making a final disposition.

DECISION

Based on the above findings and conclusions, the Executive Committee suspends David Schoonhoven from the list of WADCCB certified counselors until such time as the case against him in Outagamie County Court is adjudicated. At that time, the case may be further investigated, if necessary, for final recommendation and decision.
