MEMORANDUM AND ORDER ON SETTLEMENT CONFERENCE

An informal settlement conference was conducted in the above-captioned matter before a committee of the Medical Examining Board on October 25, 1989. The purpose of the conference was to provide interested parties with an opportunity to discuss allegations received pertaining to the practice of Dr. Yee as a physician, and to attempt to reach a fair and consensual resolution of the matter.

Presiding over the conference was H. Mowat Waldren, Jr., M.D., board secretary. Also appearing on behalf of the board was Ann Neviaser. Others present included Wayne R. Austin, the board's legal counsel, and Jonathan Becker, attorney for the Department of Regulation & Licensing, Division of Enforcement. Dr. Yee appeared in person and by Attorney William A. Wentzler.

The parties orally presented their respective positions regarding the matter to the committee, and the committee deliberated on a possible disposition of the matter. The committee thereafter presented a proposed Stipulation for Dr. Yee's consideration, a copy of which is attached hereto and made a part hereof. The Stipulation was ultimately executed by Dr. Waldren, Dr. Yee, Mr. Wentzel and Mr. Becker.

Based upon the proceedings at the conference, and upon the Stipulation of the parties, the board enters the following order.

ORDER

NOW, THEREFORE, IT IS ORDERED that the license of Jerry N. Yee, D.O., to practice medicine and surgery in the State of Wisconsin be, and hereby is, suspended for a period of one year. The suspension shall be stayed upon the following terms and conditions:

- a. Within one year from the date hereof, Dr. Yee must attend and complete that portion of a course offered by the Medical College of Wisconsin entitled Introduction to Clinical Medicine pertaining to record keeping.
- b. Within one year from the date hereof, Dr. Yee must successfully complete a home study course in pharmacology offered by the Medical College of Wisconsin.
- c. Within one year from the date hereof, Dr. Yee must complete a twelve week preceptorship, consisting of one session per week, with Dr. Herbert Swick of the Medical College of Wisconsin.

IT IS FURTHER ORDERED that for the period of the stayed suspension, Dr. Yee shall in prescribing for patients utilize only consecutively numbered three part prescription blanks, and shall on a quarterly basis submit one copy of each such prescription to the Medical Examining Board for its review and evaluation.
