ORDER GRANTING THE LIMITED LICENSE

On or about November 1, 1990, Dr. Calimlim filed her updated application for a license to practice medicine and surgery in the State of Wisconsin. Because Dr. Calimlim had been previously unsuccessful in her oral examination before the board, she again appeared before the full board for reexamination at its meeting of November 15, 1990, and the board considered her application on that date. Dr. Calimlim and the board thereafter entered into a Stipulation by which the board agreed to grant and Dr. Calimlim agreed to accept a license limited to the practice of radiation oncology.

Based upon the Stipulation, and upon other information of record, the Medical Examining Board (board) hereby grants to Elnora M. Calimlim, M.D. a license to practice medicine and surgery imposing the following terms and conditions.

- 1. Dr. Calimlim's practice of medicine and surgery shall be limited to the practice of radiation oncology, as defined by the American Board of Radiology; that is, that branch of radiology which deals with the therapeutic application of radiant energy and its modifiers, and the study and management of disease, especially malignant tumors.
- 2. Violation of the terms and conditions of this order shall constitute grounds for revocation of the limited license.

STIPULATION

- 1.
