ORDER GRANTING THE LIMITED LICENSE

On May 2, 1991, Dr. Muche filed his application for a license to practice medicine and surgery in the State of Wisconsin. Because Dr. Muche indicated on his application that he had previously received care for depressive and anxiety disorders, he was asked to appear for oral examination in connection with his application. Dr. Muche appeared for oral examination on July 24, 1991, and the board considered his application on that date. Dr. Muche and the board thereafter entered into a Stipulation by which the board agreed to issue, and Dr. Muche agreed to accept, a limited license to practice medicine and surgery. Based upon that Stipulation, and other information of record herein, the board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that Todd J. Muche be, and hereby is, granted a limited license to practice medicine and surgery in Wisconsin imposing the following terms and conditions:

1. Applicant shall continue in treatment with Michael D. Goldstein, Ph.D., or Harold H. Harsch, M.D., or another psychiatrist or psychologist satisfactory to the board, for treatment of depressive and anxiety disorders, on a schedule recommended by his therapist, but no less frequently than once each three months.
2. Applicant shall be responsible for submission to the board of formal written quarterly reports prepared by his therapist setting forth applicant's progress in therapy.
3. Applicant shall be responsible for submission of quarterly written reports from his chief of residency setting forth applicant's activities and performance in his residency program.

4. Upon request of the board, applicant shall provide current releases to any affected treatment facilities, complying with federal and state law, authorizing release of all of his medical and treatment records to the board. Copies of said releases shall be filed simultaneously with the board.

5. The term of the license shall be for one year from the date hereof. Applicant may at the time of expiration apply for renewal of the license, and shall appear before the board in support of any such application.

6. Violation of any of the terms and conditions of this order shall constitute grounds for revocation of the limited license or imposition of additional limitations as deemed appropriate by the board.

STIPULATION

On May 2, 1991, Dr. Muche filed his application for a license to practice medicine and surgery in the State of Wisconsin. Because Dr. Muche indicated on his application that he had previously received care for depressive and anxiety disorders, he was asked to appear for oral examination in connection with his application. Dr. Muche appeared for oral examination on July 24, 1991, and the board considered his application on that date.

Based upon the application, and upon other information of record, the Medical Examining Board (board) agrees to issue, and Todd J. Muche, M.D. (Applicant) agrees to accept, a limited license to practice medicine and surgery in the State of Wisconsin, imposing the following terms and conditions:

1. Applicant shall continue in treatment with Michael D. Goldstein, Ph.D., or Harold H. Harsch, M.D., or another psychiatrist or psychologist satisfactory to the board, for treatment of depressive and anxiety disorders, on a schedule recommended by his therapist, but no less frequently than once each three months.
2. Applicant shall be responsible for submission to the board of formal written quarterly reports prepared by his therapist setting forth applicant's activities and progress in therapy.
3. Applicant shall be responsible for submission of quarterly written reports from his chief of residency setting forth applicant's activities and performance in his residency program.



4. Upon request of the board, applicant shall provide current releases to any affected treatment facilities, complying with federal and state law, authorizing release of all of his medical and treatment records to the board. Copies of said releases shall be filed simultaneously with the board.

5. The term of the license shall be for one year from the date of the Order adopting this Stipulation. Applicant may at the time of expiration apply for renewal of the license, and shall appear before the board in support of any such application.


6. Violation of any of the terms and conditions of the order of the board adopting this Stipulation shall constitute grounds for revocation of the limited license or imposition of additional limitations as deemed appropriate by the board.
