ORDER GRANTING EXTENSION

---

On November 15, 1990, the Medical Examining Board issued its Final Decision and Order in the above-captioned matter. By the terms of the board's Order, Dr. Aquino was required in part to complete within six months a two day program of continuing medical education in the area of electrocardiograms and interpreting electrocardiograms.

By letter dated February 20, 1991, the board was notified by James Gutglass, attorney for Dr. Aquino, that Dr. Aquino had been called to active duty to serve in the Persian Gulf. Mr. Gutglass therefore requested an extension in the deadline for completing the CME requirement.

Based upon that request, and upon other information of record herein, IT IS ORDERED that the request of Dr. Aquino for an extension of the deadline for completion of the continuing medical education ordered by the Final Decision and Order of the board dated November 15, 1991, is hereby granted, and the deadline is hereby extended to December 31, 1991. Should Dr. Aquino's active duty status require them, he may request additional extensions.
