ORDER GRANTING THE LIMITED LICENSE

The Medical Examining Board issued its Final Decision and Order in the above-captioned matter on May 23, 1990. By the terms of the board's Order, Dr. Vosmek's license to practice medicine and surgery in Wisconsin was suspended indefinitely until satisfaction by Dr. Vosmek of terms and conditions previously imposed on his license by the Minnesota Board of Medical Examiners. The Order further provided that upon satisfaction of the Minnesota board's terms and conditions, the Wisconsin board could restore the license with limitations deemed appropriate by the board.

Following Dr. Vosmek's petition for termination of the period of suspension and his appearance before the board on July 24, 1991, the board deferred making a decision on the matter until Dr. Vosmek was able to provide the board with additional information relating to the requirements imposed by the Minnesota Board of Medical Examiners in its Order dated January 21, 1991.

More specifically, the board asked that Dr. Vosmek submit a detailed report from his treating psychologist assessing his ability to practice medicine and surgery, including any evidence of inability to practice medicine and surgery by reason of depression or other mental or physical illness. Additionally, he was asked to submit the name of a physician in the geographical area in which Dr. Vosmek intends to practice who would be willing to submit quarterly reports relating to Dr. Vosmek's observed ability to safely and competently practice medicine and surgery.

Upon receipt of an assessment performed by Steven A. Benson, Ph.D., and a letter from Thomas H. Peterson, M.D., indicating his willingness to serve as Dr. Vosmek's proctor, the board again considered the matter at its meeting of September 25, 1991.

Based upon all information of record herein, the board orders as follows:

NOW, THEREFORE, IT IS ORDERED that the license of Josef F. Vosmek, M.D., to practice medicine and surgery in the State of Wisconsin be, and hereby is, reinstated.

IT IS FURTHER ORDERED that the license shall be limited as follows:

(1) The term of the license shall be for six months. Dr. Vosmek shall appear before the board at the end of six months in support of any request for renewal of the license.

(2) During the term of the limited license, Dr. Vosmek's practice of medicine and surgery shall be supervised by Thomas H. Peterson, M.D., of the Wausau Family Practice Center, or another physician satisfactory to the board.

(3) During the term of the limited license, Dr. Vosmek shall be responsible for the submission of quarterly written reports from his supervising physician setting forth his opinion of Dr. Vosmek's demonstrated ability to safely and competently practice medicine and surgery.

(4) During the term of the limited license, Dr. Vosmek shall be responsible for submission to the board of quarterly written reports from his treating psychologist, Steven A. Benson, Ph.D., setting forth his opinion of Dr. Vosmek's continuing ability to safely practice medicine and surgery.
