ORDER REINSTATING THE LICENSE

---

On July 16, 1990, the Medical Examining Board issued its Final Decision and Order in the above-captioned matter. The board ordered that respondent's license be suspended for a period of not less than 30 days, and that the period of suspension would terminate only after submission by respondent to the board of a report prepared by a physician or physicians satisfactory to the board establishing to the satisfaction of the board that respondent does not suffer from any medical or psychological condition that would prevent her from rendering competent medical care.

Under cover of his letter dated January 7, 1991, James R. Gutglass, attorney for respondent, submitted reports prepared by James Cerletty, M.D., James Winston, M.D., David Foley, M.D., and Jeffrey Taxman, M.D., in satisfaction of the board's Order. The board considered the matter at its meeting of January 23, 1991.

Based upon the board's Order of July 16, 1990, and upon material submitted in satisfaction of the board's Order and in support of respondent's petition for reinstatement of her license, the board orders as follows:

IT IS HEREBY ORDERED that the license of Sonja Zenz, M.D., to practice medicine and surgery in the State of Wisconsin be, and hereby is, reinstated.
