### ORDER RESCINDING ACCEPTANCE OF SURRENDER

On June 22, 1989, Mark K. Roders, M.D., 54 South State Street, Painesville, Ohio, was licensed to practice medicine and surgery in Wisconsin by license #30333. By letter dated May 8, 1991, Dr. Roders requested that the board accept the surrender of his license to practice medicine and surgery. Dr. Roders explained that he is not currently practicing in Wisconsin, and that continuing to maintain the Wisconsin license is "fairly burdensome." The board considered the matter on May 22, 1991. The board granted Dr. Roders' request at its meeting of May 22, 1991.

By his letter dated June 12, 1991, Dr. Roders' requested that the board rescind its action in accepting the surrender of the license in order to avoid any future confusion as to the basis of the surrender. The board considered that request at its meeting of June 20, 1991, and orders as follows:

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the Order of the Medical Examining Board accepting the surrender of the license of Mark K. Roders, M.D. dated June 4, 1991, be, and hereby is, rescinded nunc pro tunc.
