The parties in this matter agree to the terms and conditions of the attached Stipulation as an interim disposition of this matter, subject to the approval of the Medical Examining Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Roger Mattson, Respondent, is a physician duly licensed to practice medicine and surgery in the State of Wisconsin under license #17403 which was granted on October 22, 1970.
- 2. That on May 28, 1992, Respondent was served with copies of a Notice of Hearing and Complaint related to allegations contained in investigative file 92 MED 005.
- 3. That a hearing on the allegations contained in the Complaint was scheduled for June 22, 1992.
- 4. Respondent is currently incarcerated in the Northeast Regional Correction Center, Saginaw, Minnesota and is unable to attend any evidentiary hearing on the allegations contained in the complaint.
- 5. Respondent disagrees with the allegations of wrongdoing set out in the Complaint and desires to defend himself against those allegations at a full evidentiary hearing.

6. Respondent agrees to the suspension of his license to practice medicine and surgery in the State of Wisconsin until the matters raised in the Complaint are resolved.

CONCLUSIONS OF LAW

1. The Wisconsin Medical Examining Board has jurisdiction over this matter pursuant to Wis. Stats. sec. 448.02(3) and 227.44(5).

ORDER

NOW THEREFORE, IT IS HEREBY ORDERED, that Respondent's license to practice medicine and surgery in the State of Wisconsin is suspended immediately.

IT IS FURTHER ORDERED that upon the entry of a Final Decision and Order regarding the allegations in this matter, the suspension pending hearing shall end.

IT IS FURTHER ORDERED that Respondent shall notify the Medical Examining Board, the Administrative Law Judge, John Schweitzer, and Attorney Pamela M. Stach, Department of Regulation and Licensing, Division of Enforcement of his release date from the Northeast Regional Correction Center, Saginaw, Minnesota, at least 30 days prior to the date of such release.

The rights of a party agree by this Decision to petition the Board for rehearing and to petition for judicial review are set forth on the attached "Notice of Appeal Information".

It is hereby stipulated between Roger Matteon, M.D., personally and Pamela M. Stach, Attorney for the Department of Regulation and Licensing, Division of Enforcement, as follows:

1. Roger Matteon, Respondent herein, 1015 Medical Arts Building, Duluth, Minnesota 55802, is a physician duly licensed and currently registered to practice medicine and surgery in the State of Wisconsin under license #17403 which was granted on October 22, 1970.

- 2. A formal complaint is pending before the Wisconsin Medical Examining Board and Administrative Law Judge John Schweitzer based upon allegations contained in file #92 MED 005.
- 3. A hearing on the formal complaint had been scheduled for June 22, 1992.
- 4. Respondent is currently incarcerated at the Northeast Regional Correction Center, 5378 Munger Shaw Road, Saginaw, Minnesota 55779 with an expected release date in November, 1992.
- 5. Respondent has requested an adjournment of the hearing pending his release.
- 6. An adjournment has been granted until December 7, 1992, upon the condition that the parties execute an agreement for an Interim Order upon the terms set forth in the Memorandum of Prehearing Conference dated June 10, 1992, and attached hereto.
- 7. In consideration of the facts set forth herein, the parties agree to entry of the attached Interis Order.
- 8. Violation of the terms and conditions specified in this Stipulation and Interim Order shall constitute a basis for a summary suspension of Respondent's license pursuant to Wis. Stats. sec. 448.02(4).
- 9. The parties agree to waive any proposed decision of the Administrative Law Judge and submit this Stipulation and Interim Order directly to the Medical Examining Board. All parties agree that counsel for the parties and the Board Advisor assigned to this case, may appear before the Board in open session to argue on behalf of acceptance of this Stipulation.

- 11. In the event any term or condition of this Stipulation and Interim Order is not accepted or entered by the Madical Examining Board, then no term of this Stipulation and Interim Order shall be binding in any manner on any party to this Stipulation.

MEMORANDUM OF PREHEARING CONFERENCE AND NOTICE OF RESCHEDULED HEARING Case No. LS-9205281-MED (92 MED 005)

A telephone prehearing conference was conducted in this matter on this date, in which Attorney Husby informed the undersigned administrative law judge that the Respondent is currently incarcerated, and requested an adjournment of the hearing scheduled for June 22, 1992. Mr. Husby explained that he is not licensed to practice law in Wisconsin, but that he had represented Dr. Mattson in the disciplinary proceeding in Minnesots, and that Dr. Mattson had requested his assistance. Mr. Husby's participation in this prehearing conference does not constitute practice in Wisconsin.

Attorney Stach agreed that an adjournment would be appropriate, but on behalf of the Medical Examining Board she insisted that if the hearing is delayed the interest of the public be protected by an interim order or agreement that Dr. Mattson will not practice under his Wisconsin license until this matter is resolved. Mr. Husby agreed to convey this information to Dr. Mattson, and to receive a proposed stipulation from Ms. Stach and transmit it to Dr. Mattson for his signature. On agreement of the parties, and with the understanding that a stipulation agreeable to Ms. Stach is signed by Dr. Mattson, the hearing will be rescheduled. It was further understood by the parties and agreed to, that an Answer to the Complaint in this matter will be due within twenty days of Dr. Mattson's release from the Northeast Regional Correction Center, and that the newly-scheduled hearing date may be rescheduled again upon request and for good cause.

PLEASE TAKE MOTICE that the hearing in this matter previously scheduled for June 22, 1992 is rescheduled to December 7 and December 8, 1992 in Roum 133, 1400 East Washington Ave., Madison, Wisconsin, to commune at 9:00 A.M. on the 7th.

The following notice is served on you as part of the final decision:

1. Rehearing.

Any person aggrieved by this order may petition for a rehearing within 20 days of the service of this decision, as provided in section 227.49 of the Wisconsin Statutes, a copy of which is attached. The 20 day period commences the day after personal service or mailing of this decision. (The date of mailing of this decision is shown below.) The petition for rehearing should be filed with the State of Wisconsin Medical Examining Board.

A petition for rehearing is not a prerequisite for appeal directly t circuit court through a petition for judicial review.

2. Judicial Review.

Any person aggrieved by this decision has a right to petition for judicial review of this decision as provided in section 227.53 of th Wisconsin Statutes, a copy of which is attached. The petition should be filed in circuit court and served upon the State of Wisconsin Medical Examining Board.

within 30 days of service of this decision if there has been no petition for rehearing, or within 30 days of service of the order finally disposing of the petition for rehearing, or within 30 days after the final disposition by operation of law of any petition for rehearing.

The 30 day period commences the day after personal service or mailing of the decision or order, or the day after the final disposition by operation of the law of any petition for rehearing. (The date of mailing of this decision is shown below.)
