

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Peggy Sue Buetow, R.N. (D.O.B. 11/30/52) is duly licensed as a registered nurse in the state of Wisconsin (license # 90962). This license was first granted on August 31, 1985.
- 2. Ms. Buetow's most recent address on file with the Wisconsin Board of Nursing is 6035 West Wells, Wauwautosa, WI 53213.
- 3. On or about June 29, 1991, Ms. Buetow was working as a registered nurse at Marian Catholic Home, a nursing home in Milwaukee, Wisconsin.
- 4. On that date, Ms. Buetow terminated her employment and left the facility prior to the completion of her shift and without notice to her supervisor.



CONCLUSIONS OF LAW

By the conduct described above, Peggy Sue Buetow is subject to disciplinary action against her license to practice as a registered nurse in the state of Wisconsin, pursuant to Wis. Stats. §441.07(1) and Wis. Adm. Code §N7.04.

NOW, THEREFORE, IT IS HEREBY ORDERED that Peggy Sue Buetow is hereby REPRIMANDED.

IT IS FURTHER ORDERED that within six (6) months from the effective date of this order, Ms. Buetow shall complete eight (8) hours of continuing education acceptable to the Board in the area of professional responsibility or in other areas acceptable to the Board. Ms. Buetow shall submit acceptable documentation of completion of this requirement to the Board within six (6) months of the date of this order.

Violation of any of the terms of this Order may result in a summary suspension of Ms. Buetow's license; the imposition of additional conditions and limitations; or the imposition of other additional discipline.

This Order shall become effective upon the date of its signing.

RESPONDENT :

It is hereby stipulated between Peggy Sue Buetow, personally on his own behalf and Steven M. Gloe, Attorney for the Department of Regulation and Licensing, Division of Enforcement, as follows that:

- 1. This Stipulation is entered into as a result of a pending investigation of Ms. Buetow's licensure by the Division of Enforcement (91 NUR 145). Ms. Buetow consents to the resolution of this investigation by stipulation and without the issuance of a formal complaint.
- 2. Ms. Buetow understands that by the signing of this Stipulation she voluntarily and knowingly waives her rights, including: the right to a hearing on the allegations against her, at which time the state has the burden of proving those allegations by a preponderance of the evidence; the right to confront and cross-examine the witnesses against her; the right to call witnesses on her behalf and to compel their attendance by subpoena; the right to testify herself; the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision; the right to petition for rehearing; and all other applicable rights afforded to her under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, and the Wisconsin Administrative Code.
- 3. Ms. Buetow is aware of her right to seek legal representation and has been provided the opportunity to seek legal advice prior to execution of this stipulation.
- 4. Ms. Buetow agrees to the adoption of the attached Final Decision and Order by the Board of Nursing. Respondent waives all rights to any appeal of the Board's order, if adopted in the form as attached.
- 5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall be returned to the Division of Enforcement for further proceedings. In the event that this Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.
- 6. The parties to this stipulation agree that the attorney for the Division of Enforcement may appear before the Board of Nursing for the purposes of speaking in support of this agreement and answering questions that the members of the Board may have in connection with their deliberations

on the stipulation.
