ORDER MODIFYING THE LIMITED LICENSE

On August 22, 1991, the Medical Examining Board issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent's license to practice medicine and surgery in Wisconsin was suspended for five years. All but the first 60 days of the suspension were stayed conditioned upon compliance by respondent with certain terms and conditions. Among these were that respondent participate in a recognized program for the treatment of chemical dependency, and that he participate in psychotherapy on a schedule as determined appropriate by his therapist. As a part of the drug treatment program, respondent was required to submit to random witnessed monitoring of his urine or blood for alcohol and controlled substances.

At his appearance before the board on August 19, 1992, as required by the board's Order, Dr. Cichon requested that the requirement for therapy be dropped and that the frequency of required drug screens be reduced to twice per month. Those requests were supported by Doctors Charles Lodl and Charles J. Engel, respectively.

Based upon respondent's requests, and upon all other information of record herein, the board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that paragraph 2. of the Order of the Medical Examining Board in the above-captioned matter dated August 22, 1991, is hereby dropped.

IT IS FURTHER ORDERED that paragraph 3.f. of the Order of the Medical Examining Board in the above-captioned matter dated August 22, 1991, is hereby modified to read as follows:

Page 2

f. Dr. Cichon shall supply, on at least a twice per month basis, random monitored urine or blood specimens within 24 hours of a request for said specimen made by the supervising physician or his designee. The supervising physician or his designee shall determine whether the specimen shall be a urine specimen or a blood specimen or both. Collection of these specimens shall be observed and verified by persons designated by the supervising physician. Collection and all testing of the specimens shall be the financial responsibility of Dr. Cichon or his health insurer.

IT IS FURTHER ORDERED that all other terms and conditions of the board's August 22, 1991, Order shall remain in full force and effect.
