ORDER DISMISSING THE MATTER

Pursuant to Mr. Goulet's request, a hearing in this Class I proceeding was scheduled to be conducted on August 27, 1991, into denial of Mr. Goulet's application for a real estate salesperson's license. The administrative law judge received a telephone communication from Mr. Hall on August 15, 1991, notifying the ALJ that Mr. Goulet had requested a postponement of the hearing based on a scheduling conflict. Mr. Hall neither supported nor opposed the request. Based upon Mr. Goulet's request, the hearing was adjourned to December 17, 1991.

By letter dated November 15, 1991, Mr. Goulet notified Mr. Hall that the December 17 date conflicts with his university examination schedule, and he requested a further adjournment of the hearing. Based on Mr. Goulet's request, and absent objection by Mr. Hall, the hearing was again adjourned, this time until April 15, 1992.


On April 9, 1992, the ALJ received a letter from Mr. Goulet seeking a further adjournment. Based on that letter, and again absent objection by Mr. Hall, it is ordered as follows:
