ORDER GRANTING PETITION

On November 19, 1992, the Medical Examining Board issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent's license to practice medicine and surgery in Wisconsin was limited. Limitations included a prohibition against respondent practicing anesthesiology, and the requirement that he complete SPEX within nine months of the date of the Order.

By letter dated June 7, 1993, respondent requested that he be granted an extension in the deadline for taking SPEX. The board considered the request at its meeting of June 23, 1993.


Based upon respondent's request, and upon all other information of record herein, the board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the deadline for taking SPEX established by the board's Final Decision and Order in this matter dated November 19, 1992, is hereby extended to September 14, 1993.
