ORDER MODIFYING THE LIMITED LICENSE

On September 19, 1990, the Medical Examining Board issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, the surrender of Dr. Mines' license to practice medicine and surgery in Wisconsin was accepted, and Dr Mines was granted a limited license to practice imposing certain terms and conditions. Among these were that Dr. Mines participate in a recognized program for the treatment of chemical dependency, and that he participate in a program of random witnessed monitoring of his blood or urine for alcohol and controlled substances at least weekly

Pursuant to the board's Order, Dr. Mines appeared before the board on September 23, 1993. At that time, Dr. Mines requested that the frequency of required urine screens be reduced. The board considered the request on that date.

Based upon Dr. Mine's request, and upon all other information of record herein, the board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that paragraph g. of the Final Decision and Order of the Medical Examining Board in the above-captioned matter dated September 19, 1990, is hereby modified to read as follows:

g. Dr. Mines shall supply, on at least a twice-per-month basis, random monitored urine or blood specimens within 24 hours of a request for said specimen made by the supervising physician or his designee. The supervising physician or his designee shall determine whether the specimen shall be a urine specimen or a blood specimen or both. Collection of these specimens shall be observed and verified by persons designated by the supervising physician. Collection and all testing of specimens shall be the financial responsibility of Dr. Mines or his health insurer.
