FINAL DECISION AND ORDER

ORDER 0001633

FINDINGS OF FACT

1. John M. Edwards, L.P.N. (D.O.B. 03/13/53) is duly licensed as a practical nurse in the state of Wisconsin (license #16529). This license was first granted on August 22, 1975.

2. Mr. Edwards's latest address on file with the Department of Regulation and Licensing is 7318 Hubbard Avenue, Middleton, WI 53562.

3. On June 28, 1990, the Board of Nursing issued a Final Decision and Order in the above-captioned proceeding. By the terms of the Board's Order, Mr. Edward's license to practice as a practical nurse in the state of Wisconsin was suspended for not less than two (2) years, with provision for successive three-month stays of the suspension. The Order provided that the Board would grant Mr. Edward's petition[s] for stay, conditioned upon his compliance with specified conditions and limitations on his license.

4. Mr. Edwards last requested a stay of the suspension effecting his license on April 4, 1991. The Board granted him a three month stay, which expired July 11, 1991.

CONCLUSIONS OF LAW

1. The Board of Nursing has jurisdiction in this matter pursuant to Wis. Stats. §441.07.

2. Mr. Edward's failure to request an additional stay of the suspension of his license allowed the stay of suspension to terminate; the suspension of Mr. Burt's license therefore became effective July 11, 1991.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that the stay of suspension of John M. Edwards is terminated, and that his license is suspended, effective July 11, 1991.

NOTICE OF APPEAL INFORMATION

**(Notice of Rights for Rehearing or Judicial Review,
the times allowed for each, and the identification
of the party to be named as respondent)**

The following notice is served on you as part of the final decision:

1. Rehearing.

Any person aggrieved by this order may petition for a rehearing within 20 days of the service of this decision, as provided in section 227.49 of the Wisconsin Statutes, a copy of which is attached. The 20 day period commences the day after personal service or mailing of this decision. (The date of mailing of this decision is shown below.) The petition for rehearing should be filed with the State of Wisconsin Board of Nursing.

A petition for rehearing is not a prerequisite for appeal directly to circuit court through a petition for judicial review.

2. Judicial Review.

Any person aggrieved by this decision has a right to petition for judicial review of this decision as provided in section 227.53 of the Wisconsin Statutes, a copy of which is attached. The petition should be filed in circuit court and served upon the State of Wisconsin Board of Nursing

within 30 days of service of this decision if there has been no petition for rehearing, or within 30 days of service of the order finally disposing of the petition for rehearing, or within 30 days after the final disposition by operation of law of any petition for rehearing.

The 30 day period commences the day after personal service or mailing of the decision or order, or the day after the final disposition by operation of the law of any petition for rehearing. (The date of mailing of this decision is shown below.) A petition for judicial review should be served upon, and name as the respondent, the following: the State of Wisconsin Board of Nursing.
