The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

#### FINDINGS OF FACT

- 1. Sharon R. Dean, L.P.N. (D.O.B. 04/10/47) is duly licensed as a practical nurse in the state of Wisconsin (license #30362). This license was first granted on October 5, 1990.
- 2. Ms. Dean's most recent address on file with the Wisconsin Board of Nursing is N2959 Pryse Drive, Waupaca, WI 54981.
- 3. At all times relevant to this action, Ms. Dean was working as a practical nurse at the Wisconsin Veterans Home in King, Wisconsin.
- 4. On or about November 12, 1992 at approximately 1600 hours, Ms. Dean injected a diabetic patient assigned to her care with 4 units of NPH insulin, when the patient had a blood sugar of 53. Later that evening, the patient had a blood sugar of 32, and Ms. Dean did not report this result until specifically asked regarding this patient.
  - 5. During her brief tenure of employment at the Veterans Home, additional

performance problems were noted regarding Ms. Dean's provision of nursing care.

6. In resolution of this matter, Ms. Dean consents to the following conclusions of law and order.

#### CONCLUSIONS OF LAW

By the conduct described above, Sharon R. Dean is subject to disciplinary action against her license to practice as a practical nurse in the state of Wisconsin, pursuant to Wis. Stats. §441.07(1) and Wis. Adm. Code §§N7.03(1) and 7.04(15).

#### ORDER

NOW, THEREFORE, IT IS HEREBY <u>ORDERED</u> that the license of Sharon R. Dean to practice as a nurse in the state of Wisconsin is LIMITED, subject to the following terms and conditions.

- 1. Sharon R. Dean shall limit her practice as a licensed practical nurse to participation in an LPN refresher course acceptable to the Board;
- 2. Upon receipt of acceptable documentation of successful completion by Ms. Dean of the course referred to in ¶1, above, the Board shall grant a petition by Ms. Dean for removal of the limitation referred to in ¶1, above. Acceptable documentation shall include certification from the sponsoring organization as well as an affidavit executed by Ms. Dean verifying that she attended the course in its entirety. Following her return to nursing practice,
  - a. Ms. Dean shall practice in settings where she works under supervision by another nurse or other licensed health care professional. Ms. Dean shall refrain from nursing employment as a visiting nurse or other home care provider, or as a charge nurse.
  - b. During the time these terms and conditions are in effect, Ms. Dean shall provide all current or prospective nursing employers with a copy of this Final Decision and Order.
  - c. Ms. Dean shall arrange for quarterly reports to the Board of Nursing from any nursing employer evaluating her work performance.
  - d. Ms. Dean shall report to the Board any change in nursing employment within five (5) days of any such change.
  - e. Ms. Dean may petition the Board at any time following one year of documented nursing practice pursuant to the terms of this paragraph to revise of eliminate any of the conditions of this paragraph. Denial in whole or in part of a petition under this paragraph shall not constitute denial of a license and shall not give rise to a contested case within the meaning of Wis. Stats. §§227.01(3) and 227.42.

- 3. Violation of any of the terms of this Order shall be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Ms. Dean's license; the Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order.
- This Order shall become effective upon the date of its signing.

It is hereby stipulated between Sharon R. Dean, personally on her own behalf and Steven M. Gloe, Attorney for the Department of Regulation and Licensing, Division of Enforcement, as follows that:

- 1. This Stipulation is entered into as a result of a pending investigation of Ms. Dean's licensure by the Division of Enforcement (92 NUR 218). Ms. Dean consents to the resolution of this investigation by stipulation and without the issuance of a formal complaint.
- 2. Ms. Dean understands that by the signing of this Stipulation she voluntarily and knowingly waives her rights, including: the right to a hearing on the allegations against her, at which time the state has the burden of proving those allegations by a preponderance of the evidence; the right to confront and cross-examine the witnesses against her; the right to call witnesses on her behalf and to compel their attendance by subpoena; the right to testify herself; the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision; the right to petition for rehearing; and all other applicable rights afforded to her under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, and the Wisconsin Administrative Code.
- 3. Ms. Dean is aware of her right to seek legal representation and has been afforded the opportunity to obtain legal advice prior to signing this stipulation.
- 4. Ms. Dean agrees to the adoption of the attached Final Decision and Order by the Board of Nursing. The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Board's order, if adopted in the form as attached.
- 5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall be returned to the Division of Enforcement for further proceedings. In the event that this Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.
- 6. The parties to this stipulation agree that the attorney for the Division of Enforcement and the member of the Board of Nursing assigned as an advisor in this investigation may appear before the Board of Nursing for the purposes of speaking in support of this agreement and answering questions that

the members of the Board may have in connection with their deliberations on the stipulation.

7. The Division of Enforcement joins Ms. Dean in recommending the Board of Nursing adopt this Stipulation and issue the attached Final Decision and Order.

#### NOTICE OF APPEAL INFORMATION

(Notice of Rights for Rehearing or Judicial Review, the times allowed for each, and the identification of the party to be named as respondent)

The following notice is served on you as part of the final decision:

## 1. Rehearing.

Any person aggrieved by this order may petition for a rehearing within 20 days of the service of this decision, as provided in section 227.49 of the Wisconsin Statutes, a copy of which is attached. The 20 day period commences the day after personal service or mailing of this decision. (The date of mailing of this decision is shown below.) The petition for rehearing should be filed with the State of Wisconsin Board of Nursing.

A petition for rehearing is not a prerequisite for appeal directly to circuit court through a petition for judicial review.

## 2. Judicial Review.

Any person aggrieved by this decision has a right to petition for judicial review of this decision as provided in section 227.53 of the Wisconsin Statutes, a copy of which is attached. The petition should be filed in circuit court and served upon the State of Wisconsin Board of Nursing

within 30 days of service of this decision if there has been no petition for rehearing, or within 30 days of service of the order finally disposing of the petition for rehearing, or within 30 days after the final disposition by operation of law of any petition for rehearing.

The 30 day period commences the day after personal service or mailing of the decision or order, or the day after the final disposition by operation of the law of any petition for rehearing. (The date of mailing of this decision is shown below.) A petition for judicial review should be served upon, and name as the respondent, the following: the State of Wisconsin Board of Nursing.
