ORDER TERMINATING LIMITATIONS ON THE LICENSE

On January 30, 1986, the Medical Examining Board issued its Final Decision and Order in the above-captioned matter. By the terms of the board's Order, the board accepted the voluntary surrender of Dr. Clinton's license to practice medicine and surgery in Wisconsin effective February 28, 1986.

By its *Order Granting the Limited License* dated November 25, 1992, the Medical Examining Board reinstated the license of Dr. Clinton to practice medicine and surgery on a limited basis. By the terms of that Order, Dr. Clinton was required to practice only under the supervision of another physician satisfactory to the board, and was prohibited from treating females of any age.

Consistent with the board's *Order Renewing the Limited License* dated November 29, 1993, Dr. Clinton appeared before the board at its meeting of February 23, 1994, in support of renewal of the limited license and of his petition dated February 9, 1994, by which he requested that the board increase the scope of his license to permit him to treat elderly men and women at Wauwatosa area nursing homes. The board considered the request at that time and, by its Order dated March 1, 1994, permitted Dr. Clinton to treat male patients but not female patients in a nursing home setting.

By letter dated August 10, 1994, Dr. Clinton again requested that he be permitted to do psychiatric consultations, evaluations, psychopharmacological management, brief psychotherapy and supportive therapy with women. He appeared before the board on September 22, 1994, in support of his petition, which was also supported by his practice supervisor, Basil Jackson, M.D., Ph.D. By its Order dated October 4, 1994, the board granted the petition.

Dr. Clinton again appeared before the board at its meeting of February 22, 1995, and again requested that all limitations on his license be terminated. That petition was again denied by the board's order dated March 3, 1995.

Dr. Clinton appeared once more at the board's meeting of September 27, 1995, and again requested that the limitations on his license be terminated. The board considered the matter on

that date and again at its meeting of October 26, 1995. In the intervening period between those meetings, the board received a recommendation from Ikar J. Kalogjera, M.D., Dr. Clinton's therapist, that Dr. Clinton's request be granted.

Based upon Dr. Clinton's petition and all other information of record herein, including evidence of Dr. Clinton's rehabilitation and of his full compliance with the terms and conditions placed on his license, the Medical Examining Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that all limitations on the license of Gerald L. Clinton, M.D., to practice medicine and surgery in the State of Wisconsin, as imposed by the board's Final Decision and Order in this matter dated November 25, 1992, be, and hereby are, terminated, and Dr. Clinton is hereby returned to full licensure.
