The Wisconsin Medical Examining Board received a Stipulation submitted by the parties to the above-captioned matter. The Stipulation, a copy of which is attached hereto, was executed by Dorian H. Cordes, M.D., personally, and Gilbert C. Lubcke, Attorney for the Department of Regulation and Licensing, Division of Enforcement. Based upon the Stipulation of the parties, the Wisconsin Medical Examining Board makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

- 1. Dorian H. Cordes, M.D., 1609 East Lester, Tucson, Arizona 85719, was born on 09/27/38 and has been licensed to practice medicine and surgery in the State of Wisconsin since 12/05/74, license #19089.
- 2. A formal investigation, file #92 MED 499, is pending before the Wisconsin Medical Examining Board. This investigation was commenced upon receipt of a Stipulation and Order of the Board of Medical Examiners of the State of Arizona, effective 04/03/92, formalizing Dr. Cordes' participation in an alcohol rehabilitation treatment program.

- 3. Dr. Cordes has fully complied with the alcohol rehabilitation treatment program as set forth in the Stipulation and Order of the Board of Medical Examiners of the State of Arizona and his obligations under this Stipulation and Order were terminated by the Board of Medical Examiners of the State of Arizona on 04/21/95.
- 4. Dr. Cordes has not been registered to practice medicine and surgery in the State of Wisconsin since 11/02/93, and has not practiced, in fact, in Wisconsin since approximately 1976. Dr. Cordes has no intention of renewing his registration or of returning to practice in Wisconsin at any time in the future.
- 5. Dr. Cordes, in consideration of his present intention to continue to practice in Arizona and to not return to the State of Wisconsin, has voluntarily tendered the surrender of his license to practice medicine and surgery in the State of Wisconsin.

CONCLUSIONS OF LAW

- 1. The Wisconsin Medical Examining Board has jurisdiction in this matter pursuant to sec. 448.02, Stats.
- 2. The Wisconsin Medical Examining Board has the authority to resolve this matter by stipulation without an evidentiary hearing pursuant to sec. 227.44(5), Stats.
- 3. The Wisconsin Medical Examining Board has the authority to negotiate stipulations in consideration for accepting the surrender of a license pursuant to sec. 448.02(5), Stats.

<u>ORDER</u>

NOW, THEREFORE, IT IS ORDERED that the Stipulation of the parties is approved.

IT IS FURTHER ORDERED that the Wisconsin Medical Examining Board accepts the voluntary surrender of Dr. Cordes' license to practice medicine and surgery in the State of Wisconsin, license #19089, effective on the date of this Final Decision and Order.

IT IS FURTHER ORDERED that Dr. Cordes shall not practice or attempt to practice medicine and surgery in the State of Wisconsin when not currently licensed.

IT IS FURTHER ORDERED that the investigation, file #92 MED 499, shall be and hereby is closed without further proceedings.

The rights of a party aggrieved by this Final Decision and Order to petition the Wisconsin Medical Examining Board for rehearing and to petition for judicial review are set forth in the attached "Notice of Appeal Information".

STIPULATION

DORIAN H. CORDES, M.D., RESPONDENT.

It is hereby stipulated between Dorian H. Cordes, M.D., personally, and Gilbert C. Lubcke, attorney for the Department of Regulation and Licensing, Division of Enforcement, as follows:

- 1. Dorian H. Cordes, M.D., 1609 East Lester, Tucson, Arizona 85719, was born on 09/27/38 and has been licensed to practice medicine and surgery in the State of Wisconsin since 12/05/74, license #19089.
- 2. A formal investigation, file #92 MED 499, is pending before the Wisconsin Medical Examining Board. This investigation was commenced upon receipt of a Stipulation and Order of the Board of Medical Examiners of the State of Arizona, effective 04/03/92, formalizing Dr. Cordes' participation in an alcohol rehabilitation treatment program.
- 3. Dr. Cordes has fully complied with the alcohol rehabilitation treatment program as set forth in the Stipulation and Order of the Board of Medical Examiners of the State of Arizona and his obligations under this Stipulation and Order were terminated by the Board of Medical Examiners of the State of Arizona on 04/21/95.
- 4. Dr. Cordes has not been registered to practice medicine and surgery in the State of Wisconsin since 11/02/93, and has not practiced, in fact, in Wisconsin since approximately 1976. Dr. Cordes has no intention of renewing his registration or of returning to practice in Wisconsin at any time in the future.
- 5. Dr. Cordes, in consideration of his present intention to continue to practice in Arizona and to not return to the State of Wisconsin, voluntarily surrenders his license to practice medicine and surgery in the State of Wisconsin.
- 6. The pending investigation, file #92 MED 499, will be closed without further proceedings.
- 7. The Wisconsin Medical Examining Board may enter the Final Decision and Order, a copy of which is attached hereto and incorporated herein.
 - 8. The parties waive all costs of this proceeding.

- 9. Dr. Cordes understands that by signing this Stipulation, he freely, voluntarily and knowingly waives his rights, including the right to be represented by an attorney, the right to a hearing on the allegations against him, the right to confront and cross-examine witnesses against him, the right to call witnesses on his behalf and to compel their attendance by subpoena, the right to testify on his own behalf, the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the Final Decision and Order, the right to petition for rehearing, the right to judicial review, and all other applicable rights afforded to him under the United States Constitute, the Wisconsin Constitution, the Wisconsin Statutes and the Wisconsin Administrative Code. Dr. Cordes elects to voluntarily surrender his license to practice medicine and surgery in the State of Wisconsin with full knowledge of the protections afforded him by the Americans With Disabilities Act.
- 10. The parties to this Stipulation and the Board Advisor, B. Ann Neviaser, may appear before the Wisconsin Medical Examining Board in support of this Stipulation. Any appearance by any party pursuant to this paragraph shall be preceded by proper and timely notice to all parties to this proceeding.
- 11. If any term of this Stipulation or the incorporated Final Decision and Order is not accepted by the Wisconsin Medical Examining Board, then no term of this Stipulation or the Final Decision and Order will be binding in any manner on any party, and the matter will be returned to the Division of Enforcement for further proceedings.

1. REHEARING

Any person aggrieved by this order may file a written petition for rehearing within 20 days after service of this order, as provided in sec. 227.49 of the Wisconsin Statutes, a copy of which is reprinted on side two of this sheet. The 20 day period commences the day of personal service or mailing of this decision. (The date of mailing this decision is shown above.)

A petition for rehearing should name as respondent and be filed with the party identified in the box above.

A petition for rehearing is not a prerequisite for appeal or review.

2. JUDICIAL REVIEW.

Any person aggrieved by this decision may petition for judicial review as specified in sec. 227.53, Wisconsin Statutes a copy of which is reprinted on side two of this sheet. By law, a petition for review must be filed in circuit court and should name as the respondent the party listed in the box above. A copy of the petition for judicial review should be served upon the party listed in the box above.

A petition must be filed within 30 days after service of this decision if there is no petition for rehearing, or within 30 days after service of the order finally disposing of a petition for rehearing, or within 30 days after the final disposition by operation of law of any petition for rehearing.

The 30-day period for serving and filing a petition commences on the day after personal service or mailing of the decision by the agency, or the day after the final disposition by operation of the law of any petition for rehearing. (The date of mailing this decision is shown above.)
