### ORDER MODIFYING THE LIMITED LICENSE

The Medical Examining Board issued its Final Decision and Order in the above-captioned matter on December 14, 1995. By the terms of the board's Order, Dr. Carroll's license to practice medicine and surgery in Wisconsin was suspended for 25 days, and was thereafter limited to require in part that Dr. Carroll prescribe and dispense controlled substances only pursuant to a specified procedure involving oversight by a consulting physician. Dr. Carroll was permitted to petition the board for removal of this limitation upon completion of a course entitled "Appropriate Prescribing of Controlled Substance" conducted by the Center for Substance Abuse Education and Research, Mercer University Southern School of Pharmacy in Atlanta.

By letter dated May 23, 1995, Dr. Carroll petitioned for removal of the limitation on his prescribing and dispensing controlled substances, and he included evidence of completion of the required Mercer University course. The board considered the petition at its meeting of June 28, 1995, and orders as follows:

### **ORDER**

NOW, THEREFORE, IT IS ORDERED Dr. Carroll's petition for removal of restrictions on his ability to prescribe, dispense, administer or order any controlled substance is granted, and paragraphs 1., 2. and 3., of the order of the board set forth in the board's Final Decision and Order dated December 14, 1994, are therefore struck.

IT IS FURTHER ORDERED that all other terms and conditions of the order of the board set forth in the board's Final Decision and Order dated December 14, 1994, shall remain in full force and effect.
