The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

## **FINDINGS OF FACT**

- 1. Agustin A. Garnica (DOB 08/28/54), 1031 W. Mitchell St., Milwaukee, WI 53204, is duly licensed as a barbering and cosmetology manager in the state of Wisconsin (license #18905). This license was first granted on December 5, 1988.
- 2. Tasos Hairstudio, 1031 W. Mitchell St., Milwaukee, WI 53204, is duly licensed as a barbering and cosmetology establishment in the state of Wisconsin (license #15894). This license was first granted on August 15, 1985.

- 3. Mr. Garnica is listed with the Department as the owner and manager of Tasos Hairstudio. As owner and manager, Mr. Garnica was and is at all times relevant to this action responsible for complaince with ch. 454, Stats. and chs. 2, 3 and 4 of the Wisconsin Administrative code.
- 4. On September 12, 1994, the Board imposed discipline upon the manager's and establishment licenses of Mr. Garnica and Tasos Hairstudio for the employment of unlicensed personnel. A true and correct copy of the September 12, 1994, Order is attached to this document as Exhibit A. Exhibit A is incorporated into this document by reference.
- 5. On December 4, 1995, the Board imposed discipline upon the manager's and establishment licenses of Mr. Garnica and Tasos Hairstudio for the employment of unlicensed personnel. A true and correct copy of the December 4, 1995, Order is attached to this document as Exhibit B. Exhibit B is incorporated into this document by reference.
- 6. On exact dates unknown, but beginning at least in January 1997 and continuing through at least March 1997, Mr. Garnica employed Linda Gnacinski to provide barbering and cosmetology services to patrons of the Tasos Hairstudio establishment.
- 7. At all times relevant to ¶ 6, above, Ms. Gnacinski was not licensed to practice barbering and cosmetology in the state of Wisconsin.
- 8. In resolution of this matter, Mr. Garnica consents to the entry of the following Conclusions of Law and Order.

#### CONCLUSIONS OF LAW

By the conduct described in ¶¶ 6 and 7, above, Agustin A. Garnica d/b/a Tasos Hairstudio has violated sec. 454.08(2), Stats. and Wis. Admin. Code §§ BC 2.04, 2.06(1), 2.07(2)(b) and (d).

#### ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. Agustin A. Garnica shall pay to the Department of Regulation and Licensing a forfeiture of ONE THOUSAND dollars (\$1000.00). Payment shall be submitted within ninety (90) days from the date of this order. Payment shall be made by certified check or money order, payable to the Wisconsin Department of Regulation and Licensing and sent to:

- 2. Agustin A. Garnica shall provide the Department Monitor on a quarterly basis with a copy of all reports filed in conjunction for withholding and unemployment compensation taxes as long as Linda Gnacinski works at Tasos Hairstudio or until Linda Gnacinski obtains a valid Wisconsin barbering and cosmetology license. In addition, Mr. Garnica shall include on the quarterly report the Wisconsin license numbers for all licensed employees.
- 3. In the event respondent fails to timely submit payment of the forfeiture as set forth in ¶ 1, above, the establishment license of respondent (#15894) SHALL BE SUSPENDED, without further notice or hearing, until respondent has complied with the terms of this Order.
- 4. In the event respondent fails to timely submit payment of the forfeiture as set forth in ¶ 1, above, the manager license of respondent (#18905) SHALL BE SUSPENDED, without further notice or hearing, until respondent has complied with the terms of this Order.
- 5. This Order shall become effective upon the date of its signing.

- 3. At all times relevant to this action, Mr. Garnica was acting as owner and manager of record of Taso's Hair Studio. As owner and manager of record, Mr. Garnica was and is responsible for compliance with Wis. States ch. 454 in the operation of his establishment.
  - 4. On exact dates unknown, but during the time period beginning at least

in February, 1992 and continuing on through July, 1992, Taso's Hair Studio employed Margarita Lopez Gazga and Georgina Fuentes to provide cosmetology services to patrons of the establishment.

- 5. During the period of time referred to in ¶4; above, neither Margarita Lopez Gazga nor Georgina Fuentes possessed a valid Wisconsin barbering and cosmetology license or a temporary permit to practice barbering and cosmetology in the state of Wisconsin.
- 6. In resolution of this matter, Mr. Garnica consents to the entry of the following Conclusions of Law and Order.

#### CONCLUSIONS OF LAW

Agustine Garnica and Taso's Hair Studio, by the conduct referred to in ¶¶4 and 5, above, have violated Wis. Admin. Code BC 2.04, BC 2.06(1), BC 2.07(2)(b) and BC 2.07(2)(d).

#### ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that Agustine Garnica shall pay to the Department of Regulation and Licensing a forfeiture of ONE HUNDRED dollars (\$100.00). Payment shall be submitted within thirty (30) days from the date of this order. Payment shall be made by certified check or money order, payable to the Wisconsin Department of Regulation and Licensing and sent to:



You have been issued a Final Decision and Order. For purposes of service the date of mailing of this Final Decision and Order is 12/4/97 Your rights to request a rehearing and/or judicial review are summarized below and set forth fully in the statutes reprinted on the reverse side.

#### A. REHEARING.

Any person aggrieved by this order may file a written petition for rehearing within 20 days after service of this order, as provided in section 227.49 of the Wisconsin Statutes. The 20 day period commences on the day of personal service or the date of mailing of this decision. The date of mailing of this Final Decision is shown above.

A petition for rehearing should name as respondent and be filed with the party identified below.

A petition for rehearing shall specify in detail the grounds for relief sought and supporting authorities. Rehearing will be granted only on the basis of some material error of law, material error of fact, or new evidence sufficiently strong to reverse or modify the Order which could not have been previously discovered by due diligence. The agency may order a rehearing or enter an order disposing of the petition without a hearing. If the agency does not enter an order disposing of the petition within 30 days of the filling of the petition, the petition shall be deemed to have been denied at the end of the 30 day period.

A petition for rehearing is not a prerequisite for judicial review.

## B. JUDICIAL REVIEW.

Any person aggrieved by this decision may petition for judicial review as specified in section 227.53. Wisconsin Statutes (copy on reverse side). The petition for judicial review must be filed in circuit court where the petitioner resides, except if the petitioner is a non-resident of the state, the proceedings shall be in the circuit court for Dane County. The petition should name as the respondent the Department, Board, Examining Board, or Affiliated Credentialing Board which issued the Final Decision and Order. A copy of the petition for judicial review must also be served upon the respondent at the address listed below.

A petition for judicial review must be served personally or by certified mail on the respondent and filed with the court within 30 days after service of the Final Decision and Order if there is no petition for rehearing, or within 30 days after the final disposition by operation of law of any petition for rehearing. Courts have held that the right to judicial review of administrative agency decisions is dependent upon strict compliance with the requirements of sec. 227.53 (1) (a), Stats. This statute requires, among other things, that a petition for review be served upon the agency and be filed with the clerk of the circuit court within the applicable thirty day period.

The 30 day period for serving and filing a petition for judicial review commences on the day after personal service or mailing of the Final Decision and Order by the agency, or, if a petition for rehearing has been timely filed, the day after personal service or mailing of a final decision or disposition by the agency of the petition for rehearing, or the day after the final disposition by operation of the law of a petition for rehearing. The date of mailing of this Final Decision and Order is shown above.

The petition shall state the nature of the petitioner's interest, the facts showing that the petitioner is a person aggrieved by the decision, and the grounds specified in section 227.57, Wisconsin Statutes, upon which the petitioner contends that the decision should be reversed or modified. The petition shall be entitled in the name of the person serving it as Petitioner and the Respondent as described below.
