ORDER MODIFYING THE LIMITED LICENSE

On June 20, 1991, the Medical Examining Board issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent's license to practice medicine and surgery in Wisconsin was limited to require, among other conditions, that Dr. Wetzler restrict his practice of medicine and surgery to obstetrics and gynecology, and that he not order, administer, dispense or prescribe any Schedule II Controlled Substance except in a hospital setting.

By letter dated June 21, 1996, Dr. Wetzler, by Attorney Raymond E. Schrank II, petitioned the board for a full, unrestricted license. Dr. Wetzler and Mr. Schrank appeared before the board at its meeting of August 22, 1996, at which time the petition was clarified to include only a request that the limitations on the license be modified to permit Dr. Wetzler to prescribe and dispense Schedule II Controlled Substances. Dr. Wetzler represented at his appearance before the board that he did not intend to change his practice to include prescribing or dispensing Schedule II Controlled Substances other than in a hospital setting. The board considered the request on that date.

Based upon the petition, and upon other information of record herein, the board orders as follows:

<u>ORDER</u>

NOW, THEREFORE, IT IS ORDERED that Paragraph E of the board's Order, as set forth in the Final Decision and Order in this matter dated June 20, 1991, shall be, and hereby is eliminated, and the limitation upon Dr. Wetzler's license by which he is prohibited from ordering, administering, dispensing or prescribing Schedule II Controlled Substances except in a hospital setting is thereby terminated.

IT IS FURTHER ORDERED that all other terms and conditions set forth in the board's June 20, 1991 Final Decision and Order shall remain in full force and effect.
