By its Order of October 26, 1995, the Medical Examining Board ordered that within nine months, Dr. March was required to successfully complete the SPEX examination administered by the Federation of State Medical Boards, and to complete not less than 20 hours of continuing education approved by the board, in addition to the requirements under sec. Med 13.02, Code, in the areas of hypertension and of fluid and electrolyte management.

By his letter dated June 7, 1996, to Deanna Zychowski, Dr. March requested that the deadline for completing SPEX be extended to August 9, 1996. The board considered the request at its meeting of June 27, 1996. Based upon the request, and upon all other information of record herein, the board orders as follows:

NOW, THEREFORE, IT IS ORDERED that the deadline for successfully completing SPEX, be, and hereby is, extended until August 9, 1996.
