#### ORDER MODIFYING THE LIMITED LICENSE

On August 22, 1996, the Medical Examining Board issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent's license to practice medicine and surgery in Wisconsin was reinstated and limited to require, among other conditions, that Dr. Huffman not engage in any practice of medicine and surgery which includes performing patient care while in the physical proximity of a patient or in the same room as a patient, and that he not accept any employment unless specifically permitted by the board.

By letter dated February 24, 1997, Dr. Huffman petitioned the board to permit him to be employed at Totally Positive, Milwaukee, Wisconsin, as a medical review officer. Dr. Huffman appeared before the board on March 20, 1997, in support of his petition, and the board considered the matter on that date.

Based upon the petition, and upon other information of record herein,

NOW, THEREFORE, IT IS ORDERED that the petition of Mark A. Huffman, M.D., to be permitted to be employed as a medical review officer at Totally Positive, 10629 West Oklahoma Avenue, Milwaukee, Wisconsin, under the direction of Dr. Robert Bugarin is granted.

IT IS FURTHER ORDERED that all other terms and conditions of the board's August 22, 1996, Final Decision and Order shall remain in full force and effect.
