The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Daniel Foster (DOB 12/06/51), is duly licensed in the state of Wisconsin as a barbering and cosmetology practitioner (license #70066). This license was first granted on April 24, 1990.
2. Mr. Foster's barbering and cosmetology practitioner license expired on July 1, 1995. Mr. Foster has recently applied for renewal of his practitioner license. In conjunction with the issuance of this Order, the renewal of Mr. Foster's license shall be granted.
3. On exact dates unknown, but beginning at least on January 20, 1994 and continuing on through at least March 15, 1994, Mr. Foster performed barbering and cosmetology services at Phillepe's Barber Shop, 2676 North Holton Street, Milwaukee, Wisconsin, a barbering and cosmetology establishment without a current establishment license.

4. In resolution of this matter, Mr. Foster consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

Daniel Foster, by the conduct referred in ¶3, above, has violated sec. 454.08(1)(b), Stats. and Wisconsin Administrative Code § BC 3.01(1).

ORDER


NOW, THEREFORE, **IT IS HEREBY ORDERED** that Daniel Foster shall pay to the Department of Regulation and Licensing a forfeiture of one hundred dollars (\$100.00). Payment shall be submitted within sixty (60) days from the date of this order. Payment shall be made by certified check or money order, payable to the Wisconsin Department of Regulation and Licensing and sent to:

**IT IS FURTHER ORDERED** that in the event that Respondent Daniel Foster fails to timely submit payment of the forfeiture as set forth above, the practitioner's license of Mr. Foster **SHALL BE SUSPENDED**, without further notice or hearing, until he has complied with the terms of this Order.

It is hereby stipulated between Daniel Foster, personally on his own behalf; and Steven M. Gloe, Attorney for the Department of Regulation and Licensing, Division of Enforcement, as follows:

1. This Stipulation is entered into as a result of investigation #94 BAC 006 concerning Mr. Foster's practitioner's license. Mr. Foster consents to the resolution of this matter by stipulation and without the issuance of a formal complaint.

2. Mr. Foster understands that by the signing of this Stipulation he voluntarily and knowingly waives his rights, including: the right to a hearing on the allegations against him, at which time the state has the burden of proving those allegations by a preponderance of the evidence; the right to confront and cross-examine the witnesses against him; the right to call witnesses on his behalf and to compel their attendance by subpoena; the right to testify himself; the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision; the right to petition for rehearing; and all other applicable rights afforded to him under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, and the Wisconsin Administrative Code.

3. Mr. Foster is aware of his right to seek legal representation and has been provided an opportunity to obtain legal advice prior to signing this stipulation.

4. Mr. Foster agrees to the adoption of the attached Final Decision and Order by the Barbering and Cosmetology Examining Board. The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondents waive all rights to any appeal of the attached order, if adopted in the form as attached.

5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall be returned to the Division of Enforcement for further proceedings. In the event that this Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.

6. The parties to this stipulation agree that the attorney for the Division of Enforcement and the member of the Barbering and Cosmetology Examining Board assigned as an advisor in

this investigation may appear before the Board for the purposes of speaking in support of this agreement and answering questions that the Board may have in connection with their deliberations on the stipulation.

7. The Division of Enforcement joins Mr. Foster in recommending the Board adopt this Stipulation and issue the attached Final Decision and Order.

### **1. REHEARING**

Any person aggrieved by this order may file a written petition for rehearing within 20 days after service of this order, as provided in sec. 227.49 of the *Wisconsin Statutes*, a copy of which is reprinted on side two of this sheet. The 20 day period commences the day of personal service or mailing of this decision. (The date of mailing this decision is shown above.)

A petition for rehearing should name as respondent and be filed with the party identified in the box above.

A petition for rehearing is not a prerequisite for appeal or review.

### **2. JUDICIAL REVIEW.**

Any person aggrieved by this decision may petition for judicial review as specified in sec. 227.53, *Wisconsin Statutes* a copy of which is reprinted on side two of this sheet. By law, a petition for review must be filed in circuit court and should name as the respondent the party listed in the box above. A copy of the petition for judicial review should be served upon the party listed in the box above.

A petition must be filed within 30 days after service of this decision if there is no petition for rehearing, or within 30 days after service of the order finally disposing of a petition for rehearing, or within 30 days after the final disposition by operation of law of any petition for rehearing.

The 30-day period for serving and filing a petition commences on the day after personal service or mailing of the decision by the agency, or the day after the final disposition by operation of the law of any petition for rehearing. (The date of mailing this decision is shown above.)
