PROCEDURAL HISTORY

A. This case was initiated by the filing of a complaint with the Barbering and Cosmetology Examining Board on April 14, 1997. A disciplinary proceeding (hearing) was scheduled for May 8, 1997. Notice of Hearing was prepared by the Division of Enforcement of the Department of Regulation and Licensing and sent by certified mail on April 14, 1997 to Lane Sisouvong at the address above. The notice was returned undelivered, with the notation "moved, left no address."

B. No answer was filed within twenty days, as required by sec. RL 2.09(4), Wis. Admin. Code.

- C. All time limits and notice and service requirements having been met, the disciplinary proceeding was held as scheduled on May 8, 1997. Lane Sisouvong did not appear. The Barbering and Cosmetology Board was represented by attorney Steven Gloe of the Department's Division of Enforcement.
- D. Mr. Gloe moved that Lane Sisouvong be found in default under sec. RL 2.14, Wis. Admin. Code, and the motion was granted.
- E. The hearing was recorded; no transcript was prepared. The complaint, the other official documents in the file, and the remarks of Mr. Gloe during the hearing form the basis for this Proposed Decision.

FINDINGS OF FACT

- 1. Hot Line Nails is licensed under chapter 454, Stats., to perform manicuring services in the state of Wisconsin with establishment license #693. The address on file with the department for Hot Line Nails is 2240 Prairie St., #6, Beloit, WI 53711. As of the hearing date, Hot Line Nails was no longer at this address.
- 2. Lane Sisouvong is listed with the department as the owner of Hot Line Nails.
- 3. Repeated attempts between April 14, 1997 and May 8, 1997 to locate either Hot Line Nails or Lane Sisouvong have been unsuccessful.
- 4. Under sec. RL 2.08(1), Wis. Admin. Code, a complaint may be served by mailing a copy to the respondent's last-known address, and service is complete upon mailing.
- 5. No answer was filed within twenty days, as required by sec. RL 2.09(4), Wis. Admin. Code.
- 6. On exact dates unknown, but at least on September 17, 1996, Lane Sisouvong employed Loan Tran to provide manicuring services to the public at Hot Line Nails. At no time relevant to this action did Loan Tran hold a valid Wisconsin manicurist's license.
- 7. On exact dates unknown, but at least on November 1, 1996, Lane Sisouvong employed Saylom Inthisane to provide manicuring services to the public at Hot Line Nails. At no time relevant to this action did Saylom Inthisane hold a valid Wisconsin manicurist's license.
- 8. On exact dates unknown, but at least on November 1, 1996, Lane Sisouvong employed Bounmy Sisouvong to provide manicuring services to the public at Hot Line Nails. At no time relevant to this action did Bounmy Sisouvong hold a valid Wisconsin manicurist's license.

9. On November 1, 1996, at approximately 2:00 P.M., personnel of the Division of Enforcement in the department informed Bounmy Sisouvong that individual licensure is required to perform professional manicuring services in Wisconsin. On the same day after the division personnel departed, Bounmy Sisouvong resumed the illegal provision of manicuring services at Hot Line Nails.

CONCLUSIONS OF LAW

- I. The Barbering and Cosmetology Examining Board has personal jurisdiction over Lane Sisouvong, based on her holding a credential issued by the board, and based on notice under sec. 801.04 (2), Stats. Under sec. RL 2.08 (1), Wis. Admin. Code, a respondent may be served by mailing to his or her last-known address.
- II. The Barbering and Cosmetology Examining Board is the legal authority responsible for issuing and controlling credentials for manicurists, under ch. 454, Stats., and it has jurisdiction over the subject-matter of a complaint alleging unprofessional conduct, under sections 15.08(5)(c) and 454.15, Stats.
- III. Under sec. BC 2.06, Wis. Admin. Code, as the owner of Hot Line Nails, an establishment licensed under chapter 454, Stats., Lane Sisouvong is responsible for compliance with chapter 454, Stats., and with chapters BC 2, BC 3, and BC 3, Wis. Admin. Code.
- IV. Ms. Sisouvong is in default under sec. RL 2.14, Wis. Admin. Code, and the Barbering and Cosmetology Examining Board may make findings and enter an order on the basis of the complaint and other evidence.
- V. The violations in Findings of Fact 6, 7, 8 and 9 above constitute unprofessional conduct, under section 454.04(1)(d), Stats., and section BC 2.06(1), Wis. Admin. Code, and discipline is appropriate, under section 454.15(2)(i), Stats.

ORDER

THEREFORE, IT IS ORDERED that the respondent Lane Sisouvong, d/b/a Hot Line Nails, pay a forfeiture of \$1,500 as authorized by sec. 454.15(3), Stats., within 60 days of the date on which this order is signed on behalf of the Barbering and Cosmetology Examining Board.

IT IS FURTHER ORDERED that the respondent Lane Sisouvong, d/b/a Hot Line Nails, pay the costs of this proceeding, as authorized by sec. 440.22 (2), Stats., and sec. RL 2.18, Wis. Admin. Code, within 60 days of the date on which this order is signed on behalf of the Barbering and Cosmetology Board.

IT IS FURTHER ORDERED that if the forfeiture and costs are not paid within the ordered 60 days, the establishment license issued to Hot Line Nails shall be suspended indefinitely until payment is made.

IT IS FURTHER ORDERED that if the forfeiture and costs remain unpaid one year after the date on which this order is signed on behalf of the Barbering and Cosmetology Board, and if during that period the board receives no communication attempting to resolve this matter from or on behalf of Lane Sisouvong, then the establishment license issued to Hot Line Nails shall be revoked.

OPINION

This is a disciplinary proceeding conducted under the authority of ch. 227, Stats. and ch. RL 2, Wis. Admin. Code. The Division of Enforcement in the Department of Regulation and Licensing filed a complaint with the Barbering and Cosmetology Examining Board, alleging that the respondent, Lane Sisouvong, is the owner of Hot Line Nails, a manicuring establishment licensed by the board, and that on certain dates unlicensed individuals provided manicuring services at Hot Line Nails. The burden of proof is on the Division of Enforcement to prove the allegations of the complaint by a preponderance of the evidence. The respondent is in default, having failed to file a written answer to the complaint and having failed to appear for the scheduled hearing. I therefore accept the facts alleged in the complaint as true, and the allegations of unprofessional conduct proven.

Discipline.

There is no evidence that the manicuring services provided at Hot Line Nails were incompetent or unsafe. On the other hand, because some of the individuals providing those services were unlicensed, the state has no assurance that the services they provided were competent and safe. As the owner of a licensed establishment, Ms. Sisouvong is responsible for compliance with all statutes and rules regulating the provision of manicuring services, and employment of unlicensed persons violates section 454.04(1)(d), Stats., and section BC 2.06(1), Wis. Admin. Code. Those violations are the basis of the complaint. Mr. Gloe recommended a forfeiture of \$1,500 for the offenses charged in the complaint, and since multiple offenses were observed on more than one day, this amount is justified under sec. 454.15(3), Stats.

However, at about the time this action was filed, Hot Line Nails simply disappeared, an action which deprives the state of any opportunity to regulate competence and safety, and to the charges in the complaint must be added the disappearance of both Ms. Sisouvong and Hot Line Nails. Such disregard for proper regulatory authority makes the removal of Hot Line Nails' license a more appropriate disciplinary action, not only to protect the public from unlicensed practitioners, but to remind the profession of the importance of compliance and cooperation with the board. Mr. Gloe stated that the board would prefer to deal with licensed practitioners than unlicensed ones, so the recommended order above leaves the establishment license for Hot Line Nails in place for up to one year, but if no further interest is shown by Ms. Sisouvong in her establishment's license during that time, then the license should be revoked, in order to avoid a situation of truly indefinite suspension.

Costs.

The assessment of costs against a disciplined professional is authorized by sec. 440.22(2), Wis. Stats. and sec. RL 2.18, Wis. Admin. Code. Ms. Sisouvong failed to cooperate in any way with the Department in this action, and simply disappeared. Her lack of cooperation and disregard for these proceedings make an order for costs appropriate.

1. REHEARING

Any person aggrieved by this order may file a written petition for rehearing within 20 days after service of this order, as provided in sec. 227.49 of the Wisconsin Statutes, a copy of which is reprinted on side two of this sheet. The 20 day period commences the day of personal service or mailing of this decision. (The date of mailing this decision is shown above.)

A petition for rehearing should name as respondent and be filed with the party identified in the box above.

A petition for rehearing is not a prerequisite for appeal or review.

2. JUDICIAL REVIEW.

Any person aggrieved by this decision may petition for judicial review as specified in sec. 227.53, Wisconsin Statutes a copy of which is reprinted on side two of this sheet. By law, a petition for review must be filed in circuit court and should name as the respondent the party listed in the box above. A copy of the petition for judicial review should be served upon the party listed in the box above.

A petition must be filed within 30 days after service of this decision if there is no petition for rehearing, or within 30 days after service of the order finally disposing of a petition for rehearing, or within 30 days after the final disposition by operation of law of any petition for rehearing.
