ORDER ADOPTING STIPULATION

On April 7, 1997, Rhonda M. Anderson filed an application for a Wisconsin barbering and cosmetology manager's license. The information received in the application process reflects that from at least February 7, 1997, until at least June 4, 1997, Ms. Anderson operated an unlicensed barbering and cosmetology establishment located at 2800 Cleveland Avenue, Stevens Point, Wisconsin in violation of section 454.08(1)(b) of the Wisconsin statutes and Wisconsin Administrative Code §§ BC 3.01(1) and (2) and BC 3.03(5). The Board and Applicant have entered into a Stipulation by which the Board agreed to issue, and applicant agreed to accept a manager's license subject to the following conditions. Based upon the stipulation and information of record herein, it is ORDERED as follows:

**ORDER**


NOW, THEREFORE, IT IS ORDERED that Rhonda M. Anderson is granted a manager's license, subject to the following terms and conditions:


Rhonda M. Anderson shall pay to the Department of Regulation and Licensing a forfeiture of one hundred dollars (\$100.00). Upon receipt of the \$100.00 forfeiture, the Board shall issue applicant's manager's license.



It is hereby stipulated between the above-referenced applicant and the State of Wisconsin Barbering and Cosmetology Examining Board as follows:



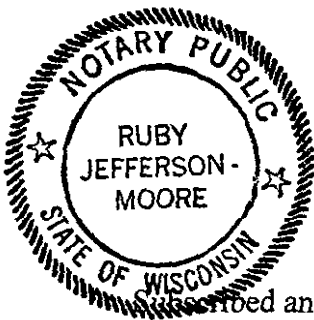
