ORDER ADOPTING STIPULATION 96BAC157

On or about June 7, 1997, Michelle Miller, 506 Black Earth Rd., Wales, WI 53183 filed an application for a barbering and cosmetology establishment license. The information received in the application process reflects that at least from May 14, 1997 until at least June 5, 1997, Ms. Miller was operating Savannah's Tanning & Hair Design, an unlicensed barbering and cosmetology establishment, in violation of section 454.08(2)(a) of the Wisconsin statutes and Wisconsin Administrative Code §§ BC 3.01(1) and 3.03(5). The Board and Applicant have entered into a Stipulation by which the Board agreed to issue and applicant agreed to accept, a barbering and cosmetology establishment license subject to specified conditions. Based upon the stipulation and information of record herein, it is ORDERED as follows

ORDER

NOW, THEREFORE, IT IS ORDERED that Michelle Miller, d/b/a Savannah's Tanning & Hair Design, is granted a barbering and cosmetology establishment license, subject to the following terms and conditions:

Michelle Miller shall pay to the Department of Regulation and Licensing a forfeiture of one hundred dollars (\$100.00). Upon receipt of the \$100.00 forfeiture, the Board shall issue applicant's establishment license.



1. REHEARING

Any person aggrieved by this order may file a written petition for rehearing within 20 days after service of this order, as provided in sec. 227.49 of the *Wisconsin Statutes*, a copy of which is reprinted on side two of this sheet. The 20 day period commences the day of personal service or mailing of this decision. (The date of mailing this decision is shown above.)

A petition for rehearing should name as respondent and be filed with the party identified in the box above.

A petition for rehearing is not a prerequisite for appeal or review.

2. JUDICIAL REVIEW.

Any person aggrieved by this decision may petition for judicial review as specified in sec. 227.53, *Wisconsin Statutes* a copy of which is reprinted on side two of this sheet. By law, a petition for review must be filed in circuit court and should name as the respondent the party listed in the box above. A copy of the petition for judicial review should be served upon the party listed in the box above.

A petition must be filed within 30 days after service of this decision if there is no petition for rehearing, or within 30 days after service of the order finally disposing of a petition for rehearing, or within 30 days after the final disposition by operation of law of any petition for rehearing.

The 30-day period for serving and filing a petition commences on the day after personal service or mailing of the decision by the agency, or the day after the final disposition by operation of the law of any petition for rehearing. (The date of mailing this decision is shown above.)
