The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Lan My Thi Le (DOB 04-02-65) of 985 Alpine Court, Oshkosh, WI 54901, is duly licensed as a manicurist in the state of Wisconsin (license #2994). This license was first granted on July 25, 1997.
2. California Nails, 555 W. Grand Avenue, Wisconsin Rapids, WI 54495, is duly licensed as a manicuring establishment in the state of Wisconsin (license #785). This license was first granted on October 4, 1996.
3. On exact dates unknown, but at least on March 7, 1997, Lan My Thi Le was employed at California Nails to provide manicuring services to the public. At no time relevant to this action did Ms. Le hold a valid and current Wisconsin manicurist license.
4. In resolution of this matter, Ms. Le consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

By the conduct referred to in ¶ 3, above, Lan My Thi Le, violated sec. 454.04(1)(d), Stats.

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that Lan My Thi Le, shall pay to the Department of Regulation and Licensing a forfeiture of ONE HUNDRED dollars (\$100.00). Payment shall be submitted within 30 days from the date of this order. Payment shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to:

IT IS FURTHER ORDERED that in the event Lan My Thi Le fails to timely submit payment of the forfeiture as set forth above, the manicurist license of Respondent (#2994) **SHALL BE SUSPENDED**, without further notice or hearing, until Respondent has complied with the terms of this Order.

This Order shall become effective upon the date of its signing.
