The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

# **FINDINGS OF FACT**

- 1. Julie A. Roberts, N4297 Driftwood Rd., New London, WI 54961 is indentured as a barbering and cosmetology apprentice (permit #7651) with Silken Treasures Salon. This permit was granted on March 30, 1998.
- 2. Silken Treasures Salon, 112 W. Wolf River Ave., New London, WI 54961 is duly licensed as a barbering and cosmetology establishment in the state of Wisconsin (license #26840). This license was first granted on October 2, 1997. Julie A. Roberts is listed with the Department of Regulation and Licensing as the owner of Silken Treasures Salon. As owner, Ms. Roberts was and is at all times relevant to this action responsible for compliance with ch. 454, Stats. and Wisconsin Administrative Code chs. BC 3 and 4.
- 3. On exact dates unknown, but beginning at least on April 1, 1998 and continuing on through August 20, 1998, Julie A. Roberts provided barbering and cosmetology services at Silken Treasures Salon. At no time relevant to this action was a manager employed at Silken Treasures Salon to have direct authority over the operations of the establishment and maintain visual contact with the practical work of the apprentice.
- 4. In resolution of this matter, Ms. Roberts, d/b/a Silken Treasures Salon, consents to the entry of the following Conclusions of Law and Order.

# **CONCLUSIONS OF LAW**

By the conduct referred to in  $\P$  3, above, Julie A. Roberts, d/b/a Silken Treasures Salon, violated secs. 454.08(6), 454.10(3) and 454.15(2)(i), Stats. and Wis. Admin. Code §§ BC 2.04(1), 2.06(1) and 2.06(2)(a).

# ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that Julie A. Roberts, d/b/a Silken Treasures Salon, shall pay to the Department of Regulation and Licensing a forfeiture of TWO HUNDRED dollars (\$200.00). Payment shall be submitted within 30 days from the date of this order. Payments shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to:

**IT IS FURTHER ORDERED** that in the event Julie A. Roberts fails to timely submit payment of the forfeiture as set forth above, the establishment license of Silken Treasures Salon (#26840) **SHALL BE SUSPENDED**, without further notice or hearing, until Respondent has complied with the terms of this Order.

This Order shall become effective upon the date of its signing.
