ORDER ADOPTING STIPULATION

On or about November 24, 1998, Pamela Jo Brown, 2608 N. 89th St., Wauwatosa, WI 53226 filed an application for a manicuring establishment license. The information received in the application process reflects that at least from June 1998 until at least November 1998, Ms. Brown was operating Onyx Nail Salon, an unlicensed manicuring establishment located at 11708 W. North Ave., Wauwatosa, WI 53226 in violation of section 454.08(2)(d) of the Wisconsin statutes and Wisconsin Administrative Code § BC 3.03(5). The information further reflects that Ms. Brown was providing manicuring services to the public without a manicuring license, in violation of sec. 454.04(1)(d), Stats. The Board and Applicant have entered into a Stipulation by which the Board agreed to issue and applicant agreed to accept, a manicuring establishment license subject to specified conditions. Based upon the stipulation and information of record herein, it is ORDERED as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that Pamela Jo Brown, d/b/a Onyx Nail Salon, is granted a manicuring establishment license, subject to the following terms and conditions:

Pamela Jo Brown shall pay to the Department of Regulation and Licensing a forfeiture of two hundred dollars (\$200.00). Upon receipt of the \$200.00 forfeiture, the Board shall issue applicant's establishment license.
