On July 28, 1997, the State of Wisconsin Real Estate Board issued an *Order Granting Limited Real Estate Broker's License* placing certain enumerated limitations on the license of the respondent, David V. Jennings III, to practice as a real estate broker. The board's *Order* also provided that the respondent could request removal of the limitations after two years.

At its meeting on August 26, 1999, the board considered information indicating that Mr. Jennings had successfully completed the requirements for obtaining a reinstatement of an unlimited license to practice as a real estate broker.

Based upon a review of the information received, the board issues the following,

ORDER

NOW, THEREFORE, IT IS ORDERED that all conditions and limitations previously imposed upon the license of David V. Jennings III to practice as a real estate broker in the state of Wisconsin, pursuant to the *Order Granting Limited Real Estate Broker's License* of July 28, 1997, be and hereby are removed.
