The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Department. The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department of Regulation and Licensing in this matter adopts the attached Stipulation and makes the following:

# **FINDINGS OF FACT**

- 1. On or about September 9, 1997, Frank P. Sorano (DOB 07-14-43) submitted an application for a Private Security Permit to the Wisconsin Department of Regulation and Licensing. Mr. Sorano's last known address is 4980 Sutton Ln., Greendale, WI 53219.
- 2. In Mr. Sorano's application materials, he indicated "No" in response to the following question:

Have you ever been convicted of a misdemeanor or a felony, or driving while intoxicated (DWI), in this or any other state, **OR** are criminal charges or DWI charges currently pending against you? If YES, complete and attach Form #2252.

3. On or about September 11, 1997, The Department of Regulation and Licensing approved Mr. Sorano's application and granted him a private security permit (#5244). Mr. Sorano was eligible for licensure under the grandfather provisions of 1995 Senate Bill 597, Section 44.

- 4. Subsequent to the issue of this permit, the Department was notified that Respondent had been found guilty of a crime. Respondent was convicted of forgery on July 3, 1964. A true and correct copy of the Complaint, Judgment Roll and Commitment are attached to this Order as Exhibit A. Exhibit A is incorporated by reference into this Order.
- 5. In resolution of this matter, Mr. Sorano consents to the entry of the following Conclusions of Law and Order.

# **CONCLUSIONS OF LAW**

1. The provision of false information in an application for a private security permit constitutes a violation of sec. 440.26(6)(a)3., Stats.

# **ORDER**

NOW, THEREFORE, **IT IS HEREBY ORDERED** that Frank P. Sorano, is **REPRIMANDED**.

**IT IS FURTHER ORDERED** that within sixty (60) days from the date of this order, Mr. Sorano shall pay the costs of this proceeding in the amount of TWO HUNDRED dollars (\$200.00). Payment shall be made by certified check or money order, payable to the Wisconsin Department of Regulation and Licensing and sent to:
