On January 13, 1999, the State of Wisconsin Pharmacy Examining Board reviewed the written petition by Wisconsin I.V. Affiliates, LLC, for the issuance of a pharmacy license with a variance to meeting the requirements of Wis. Adm. Code Phar 6.06 (1) (a) (b) (c) (d) (e) (f) (g) (h) and (i). The variance was sought based upon the representation that Wisconsin IV Affiliates, LLC was intended to be an infusion pharmacy, which would dispense only parenteral medications compounded from sterile products, using sterile syringes or transfer devices.

Based upon the board's review of the petition and the information submitted the board ordered as follows:

IT IS HEREBY ORDERED that Wisconsin I.V. Affiliates, LLC be issued a limited pharmacy license, with pharmacy practice restricted to the operation of an infusion pharmacy, which shall dispense only parenteral medications compounded from sterile products, using sterile syringes or transfer devices.

IT IS FURTHER ORDERED that a variance to meeting the requirements of Wis. Adm. Code Phar 6.06(1)(a)(b)(c)(d)(e)(f)(g)(h) and (i) is granted.
