ORDER REVOKING
PRIVATE SECURITY PERMIT

On December 16, 1998, the Department of Regulation and Licensing issued a *Final Decision and Order Granting a Limited Security Permit* to Daniel W. Hornbeck. The order set forth limitations upon the registration.

The department has received none of the required reports set forth in the Final Decision and Order. Per the Order, failure by Mr. Hornbeck to timely comply with the terms of the limitation shall result in the revocation of his limited private security permit without further notice, hearing or other proceedings.

Accordingly, based upon the terms of the order,

THE DEPARTMENT HEREBY REVOKES the limited private security permit (#9826) of Daniel W. Hornbeck to act as a private security guard.
