ORDER ADOPTING STIPULATION

---

On July 27, 1999, Ms. Chase filed her application for a license to practice as a practical nurse in the State of Wisconsin. Because Ms. Chase indicated on her application that she had an arrest record related to abuse of alcohol, she was asked to appear before the board for oral interview in connection with her application. Ms. Chase appeared before the board at its meeting of November 5, 1999, and the board considered the application on that date. Thereafter, the board and Ms. Chase entered into a Stipulation, by which the Board of Nursing (board) agreed to grant, and Ms. Chase agreed to accept, a limited license to practice nursing in the State of Wisconsin. Based upon that Stipulation, the board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that Katherine L. Chase is hereby granted a limited license to practice as a licensed practical nurse in Wisconsin imposing the following terms and conditions.

1. The term of the limitation shall be for one year. At the end of one year, Ms. Chase may petition the board for grant of a full unrestricted license, and that petition shall be granted upon demonstration of full compliance with the terms and conditions set forth herein.
2. For the period of limitation, Ms. Chase shall arrange for quarterly reports from her nursing employer(s) reporting the terms and conditions of her employment and evaluating her work performance. These reports shall be submitted to the department monitor in the Department of Regulation and Licensing, Division of Enforcement, P.O. Box 8935, Madison, WI 53708, on a schedule as directed by the department monitor. The monitor may be reached by telephone at (608) 267-7139, or by facsimile at (608) 266-2264.

STIPULATION

1. The term of the limitation shall be for one year. At the end of one year, Ms. Chase may petition the board for grant of a full unrestricted license, and that petition shall be granted upon demonstration of full compliance with the terms and conditions set forth herein.

2. For the period of limitation, Ms. Chase shall arrange for quarterly reports from her nursing employer(s) reporting the terms and conditions of her employment and evaluating her work performance. These reports shall be submitted to the department monitor in the Department of Regulation and Licensing, Division of Enforcement, P.O.
