On March 27, 1997, the Wisconsin Real Estate Board issued a *Final Decision and Order* placing certain limitations upon the real estate broker's license of Joan M. McIntyre.

At its meeting on January 28, 1999, the board received information indicating that Ms. McIntyre had successfully complied with the limitations and is otherwise qualified for a return to the unrestricted practice of real estate.

Accordingly, based upon a review of the information received, the board issues the following,

ORDER

NOW, THEREFORE, IT IS ORDERED that all conditions and limitations previously imposed upon the license (#44722) of Joan M. McIntyre to practice as a real estate salesperson in the state of Wisconsin, pursuant to the *Final Decision and Order*, dated March 27, 1997, be and hereby are removed.
