On November 26, 1997, the Department of Regulation and Licensing issued a *Final Decision and Order Granting Limited Real Estate Salesperson's License*, that placed certain limitations upon the real estate salesperson's license of Robert D. Chitko.

At its meeting on April 22, 1999, the Wisconsin Real Estate Board received information indicating that Mr. Chitko has successfully complied with the limitations and is otherwise qualified to receive an unlimited license to practice as a real estate salesperson.

Accordingly, based upon a review of the information received, the board issues the following,

ORDER

NOW, THEREFORE, IT IS ORDERED that all conditions and limitations previously imposed upon the license of Robert D. Chitko to practice as a real estate salesperson in the state of Wisconsin, be and hereby are removed.
